## ORDER:

In the Government Order first read above, the post of Superintending Engineer with the powers of the Chief Engineer (Highways) was created in the Directorate of Rural Development and Panchayat Raj to advice and assist the Director of Rural Development and Panchayat Raj in all technical matters. Now, the post is being filled up by promotion from the post of Executive Engineer of the Rural Development and Panchayat Raj Department.

- 2. In the Government Order second read above, as per the instructions of the Ministry of Rural Development, Government of India, a State level NRECA Cell was created and one post of Executive Engineer (RD) along with other technical staff were sanctioned in the Directorate of Rural Development and Panchayat Raj Department.
- 3. In the Government Order third read above, as per the decisions taken by the Steering Committee of the Mahatma Gandhi National Rural Employment Guarantee Scheme (MGNREGS) held on 30.04.2013, an additional post of Executive Engineer was also created to strengthen the State Unit of MGNREGS for better implementation and monitoring.

In the proposals fourth read above, the Director of Rural Development and par hayat Raj has stated that the financial budget allotted for the Mahatma Gandhi National Rural Employment Guarantee Scheme (MGNREGS) in the previous years and the various works taken in convergence with other line departments have increased year by year, necessitating the need for creation of an exclusive post of Superintending Engineer for Mahatma Gandhi National Rural Employment Guarantee Scheme (MGNREGS) to have better monitoring and liasioning. Till date, no post in the cadre of Superintending Engineer was created for monitoring and implementing the Mahatma Gandhi National Rural Employment Guarantee Scheme MGNREGS) in the State. Hence there is a need to create the post of Superintending Engineer in the Directorate of Rural Development and Panchayat Raj exclusively for Mahatma Gandhi National Rural Employment Guarantee Scheme (MGNREGS) which can be done by upgrading one post of Executive Engineer which was created in the Government Order third read above. By this procedure information on assets which are created or completed under MGNREG Scheme with effect from 01.04.2016 will be Geo tagged with photograph by MGNREG Scheme spatial Emulator at Gram panchayat level. Considering the volume of works and crores of rupees spent year after year, it would be ideal to upgrade one post of Executive Engineer (RD) to that of Superintending Engineer exclusively for MGNREG Scheme that the financial burden will be less as this is not an additional post, its only an upgraded post for which the payment is to be made from MGNREG Scheme Administrative Fund.
