ORDER:

Development and Panchayat above the Additional Chief Secretary/Commissioner of Rural are conducted for the departmental officials like Rural Welfare Officers, Junior Assistants, Deputy Block Development Officers, Overseers, Road Inspectors, Union Engineers etc. through 5 following Regional Institutes of Rural Development and Panchayat

Regular training, computer training and sponsored trainings by National Institute of Rural Development and Panchayat Raj (NIRD&PR) and State Institute of Rural Development and Panchayat Raj (SIRD&PR) Workshops, Seminars Training of Trainees for Rural Development Officials and elected representatives are conducted in Regional Institutes of Rural Development and Panchayat Raj.

Further, special training under Rajiv Gandhi Sashaktikaran Abhiyan (RGSA) / Indira Awass Yojana (IAY) / National Rural Livelihood Mission (NRLM) / (SC/ST) / Women Empowerment / Sanitation etc. and this year Village Panchayat Development Plan (VPDP) training are being imparted to Rural Development and Panchayat Raj Department officials and elected representatives with the approval of the Government.

- 3. The Additional Chief Secretary / Commissioner of Rural Development and Panchayat Raj (Training) has stated that during the year 2016-17, it has been tentatively planned to give regular training for 60 batches @ 30 persons per batch, totalling to 1800 persons (11100 Mandays) and 26 batches @ 25 persons per batch totalling to 650 persons (5000 Mandays). For conducting these trainings an amount of Rs.37,59,000/- (Approximate) will be required towards expenditure in each Regional Institute of Rural Development. Thus total annual expenditure of (5xRs.37,59,000) Rs.1,87,95,000/- (Rupees One Crore eighty seven lakhs ninety five thousand only) will be required towards boarding, lodging, training materials, training kits, documentation, miscellaneous expenses etc. for conducting 16,100 Mandays of training to 2450 Participants in all the 5 Regional Institutes of Rural Development and Panchayat.
- 4. In the letter second read above, the Additional Chief Secretary / Commissioner of Rural Development and Panchayat Raj has further stated that in the Government Order first read above, the Government had allotted Rs.1.91 Crore for the first time to provide boarding, lodging, training materials, training kits etc. to the trainees drafted from Rural Development and Panchayat Raj Department and Panchayat Raj Institutions for the year 2015-2016 from State Finance Commission Grant in the ratio of 60% from Village Panchayat, 32% Panchayat Union and 8% from District allotment. This fund was allocated to the Regional Institutes of Rural Development and Panchayat Raj. Based on the above Government Order the Commissioner of Rural Development and Panchayat Raj had released Rs.1,65,00,000/- in two instalments to all 5 Regional Institutes of Rural Development and Panchayat Raj.
- Panchayat Raj (Training) has also stated that in the last year between September and December training could not be conducted as per calender approved due to the construction in the Regional Institute of Rural Development of Bhavanisagar and therefore many participants were unable to attend training programmes due to their works relating to the rain, heavy flood, flood relief, elections etc., and therefore the expenditure incurred upto 21.03.2016 by the Principals of all Regional Institutes of Rural Development and Panchayat Raj is Rs.84,39,483/- only. The details of fund allotted from State Finance Commission grant to all Regional Institutes of Rural Development and Panchayat Raj and the expenditure is tabulated below:

Out of Rs.1,91,00,000/- released, the unspent available balance of Rs.1,08,82,643/- (Rupees One Crore Eight Lakhs eighty two thousand Six hundred and forty three only) is kept in Regional Institutes of Rural Development and Panchayat Raj and Office of the Commissioner of Rural Development and Panchayat Raj (Training) and she has requested to use the unspent balance of Rs.1,08,82,643/- as "Training Corpus Fund" to be utilized as Institutional Development Fund in future to conduct special taining programmes / to achieve various training targets as per the guidelines of the Government to be issued.

- 6. The Additional Chief Secretary / Commissioner of Rural Development and Panchayat Raj (Training) has also stated that during the discussion with all the Principals of Regional Institute of Rural Developments held on 04.04.2016 at Regional Institute of Rural Development and Panchayat Raj, Krishnagiri for the preparation of training calendar and training management for the year 2016-2017, they have requested for sanction of amount towards the boarding, lodging, training material costs, training kits, documentation etc. for the year 2016-2017.
- 7. The Additional Chief Secretary / Commissioner of Rural Development and Panchayat Raj (Training) has therefore requested the Government to consider the proposal and sanction the training cost amount to the tune of Rs.1,87,95,000/- (Rupees One Crore eighty seven lakhs ninety five thousand only) @ Rs.37,59,000/- for each Regional Institute of Rural Development and Panchayat Raj for the year 2016-2017 from the State Finance Commission Grant and has also requested to permit 5 Regional Institutes of Rural Development and Panchayat Raj and Training Commissionerate to retain the unspent amount of Rs.1,08,82,643/- in the Training Corpus Fund, which can be utilized as per the Institutional Development Fund guidelines to be issued by the Government.
- examination against the proposed amount of Rs.1,87,95,000/- the Government, have decided to permit to utilize the fund of Rs.79,12,357/- (Rupees Seventy nine lakhs twelve thousand three hundred and fifty seven only) from the State Finance Commission Grant considering the availability of unspent State Finance Commission amount of Rs.1,08,82,643/- sanctioned for the year 2015-2016 so as to utilize Rs.1,87,95,000/-(Rs.1,08,82,643/- + Rs.79,12,357/-) as required towards training cost for the year 2016-2017.
