### **ORDER:**

In the reference 1<sup>st</sup> read above, the Election Commission of India has given instructions to conduct the Training of Trainers and Facilitators (TTF) Programme in Tamil Nadu in view of the General Elections to Tamil Nadu Legislative Assembly, 2016.

2. In the reference second read above, the Additional Chief Secretary/Commissioner, Rural Development & Panchayat Raj (Training) was requested to allot the four training centres for conduction of the training

programmes and a detailed training plan for the Training of Trainers and Facilitators (TTF) Programme consisting of the details of batches, proposed dates, venues and no. of participants were sent to him and also requested to conduct the training in 10 batches in the following four centres from 22.02.2016 to 11.03.2016.

1. State Institute of Rural Development, Maraimalainagar, Chennai District.
2. Regional Institute of Rural Development, S.V. Nagaram, Tiruvannamalai District.
3. Regional Institute of Rural Development, T. Kallupatti, Madurai District
4. Regional Institute of Rural Development, Pattutkottai, Thanjavur District.

In the reference 3<sup>rd</sup> read above, the Additional Chief Secretary/Commissioner, Rural Development & Panchayat Raj (Training) has stated that the Director, State Institute of Rural Development and the Principals, Regional Institute of Rural Development, S.V. Nagaram, Pattukottai, T.Kallupati have conducted the Training of Trainers and Facilitators (TTF) Programme on the respective dates (5 days) for the 460 participants and the total expenditure was Rs.11,44,357/- (Rupees eleven lakhs forty four thousand three hundred and fifty seven only) to conduct the above Training of Trainers and Facilitators (TTF) Programme and requested to release an amount of Rs.11,44,357/- (Rupees eleven lakhs forty four thousand three hundred and fifty seven only), for the conduct of Training of Trainers and Facilitators (TTF) Programme to the Account No.6349368985 (Indian Bank, Saidapet Branch) of this Commissionerate so as to release the same to the Institutes concerned through ECS.

The Government, after careful consideration of the claims, accord sanction for an expenditure of Rs.11,44,357/- (Rupees eleven lakhs forty four thousand three hundred and fifty seven only) towards the settlement of the expenditure incurred in connection with the Training of Trainers and Facilitators (TTF) Programme held at State Institute of Rural Development, Maraimalainagar, Chennai, the Regional Institute of Rural Development, S.V.
