Indira Awaas Yojana – Announcement made by Hon'ble Chief Minister under Rule 110 – Budget Announcement (2013-14) – One lakh Indira Awaas Yojana houses to be constructed in the year 2013-14 – Release of Rs.60339.22 lakh (Rupees Sixty thousand three hundred and thirty nine lakhs and Twenty two thousand only) as State share for the construction of 88,436 houses under Indira Awaas Yojana for the year 2013-14– Orders issued.

ORDER:

On 9.4.2013, Hon'ble Chief Minister made an announcement under Rule 110 that unit cost of per Indira Awaas Yojana house will be raised from Rs.1.00 lakh to Rs.1.20 lakh.

2. During the Budget speech on 21.3.2013, Hon'ble Minister for Finance, among others, made the following Announcement:

"In the coming financial year also, under Indira Awaas Yojana, one lakh houses will be taken up during 2013-14."

3. In pursuance of above announcements, in the letter read above, the Commissioner of Rural Development and Panchayat Raj has stated that the Government of India has communicated the State wise allocation under Indira Awaas Yojana for the year 2013-14. 88,436 houses are allocated to Tamil Nadu for the year 2013-14 with the community wise break up as detailed below:

The Government of India has provided 4% of the total cost for administration. The cost sharing pattern between the Centre and State is 75:25. Accordingly, the cost details are as below:
