ORDER:

In the Government Order first read above, orders along with the detailed guidelines were issued for the implementation of Self Sufficiency Scheme during 2012-2013 and sanction was accorded for a sum of Rs.100 crores.

2) Out of the financial sanction of Rs.100 crores a sum of Rs.42.50 crores (First quarter Rs.21,25,00,000/-, second quarter Rs.21,25,00,000/-) was released in the Government Order first read above.

3) In the letter second read above, the Commissioner of Rural Development and Panchayat Raj has requested the Government to release the balance amount of Rs.57,50,00,000/- since the works taken-up under Self Sufficiency Scheme are in progress in all districts.

4) After careful examination, the Government has now decided to release further a sum of Rs.57,50,00,000/- (Rupees fifty seven crores and fifty lakhs only) under Self Sufficiency Scheme apart from the funds released in the Government Order first read above.

5) The Commissioner of Rural Development and Panchayat Raj is permitted to incur the expenditure sanctioned in para 4 above by relax the Quarterly Control of Appropriation System as ordered in Government Order 4th read above, subject to condition that the over all expenditure under Demand No.42 during the vote on account

period indicated in Government Order third read above, should be contained within the appropriation available in the vote on account for the year 2013-2014.

6) The amount sanctioned in para 4 above shall be debited under the following Heads of Account:-

2515-00-Other Rural Development Programmes – 800 other expenditure – Schemes in the Twelfth Five Year Plan – II State Plan – JW Implementation of Self Sufficiency Scheme 09 Grants in Aid – 03 Grants for specific Schemes.(DPC 2515 00 800 JW 0934)

7) The Commissioner of Rural Development and Panchayat Raj is authorised to draw the amount sanctioned in para (4) above and disburse to the Districts and he is requested to complete the works and send compliance report to the Government.
