### ORDER:

In the Government Order first read above, orders were issued according Administrative Sanction for a sum of Rs.100 Crore along with detailed Guidelines for the implementation of Namakku Naame Thittam (NNT) for the year 2021-2022 and sanction was accorded for a sum of Rs.50 Crore (Rupees Fifty Crore only) being 50% of fund out of Budget Allocation of Rs. 100 Crore for the implementation of Namakku Naame Thittam (NNT) for the year 2021-2022.

2. In the letter second read above, the Director of Rural Development and Panchayat Raj has stated that a copy of the Government order and the tentative District wise allocation under NNT 2021-2022 were communicated to the District Collectors/ Chairmen, District Rural Development Agencies requesting to take up works strictly as per guidelines and to take necessary action to mobilize Public Contribution in proportion to the tentative Government allocation for the year 2021-22. As per online report dated 3.3.2022, Districts have taken up 269 works for the Administrative Value of Rs.21.12 Crore under NNT 2021-2022. Hence, the Director of Rural Development and Panchayat Raj has requested the Government to issue necessary orders for the release of balance 50% of the funds under Namakku Naame Thittam (NNT). A sum of Rs.1.25 Crore is reported to be available in the Namakku Naame Thittam (NNT) bank accounts under the control of Director of Rural Development and Panchayat Raj.

3. The Government have carefully examined the proposal of the Director of Rural Development and Panchayat Raj for implementation of the Namakku Naame Thittam (NNT) for the year 2021-2022 in detail, decided to accept the same and sanction a sum of Rs.50,00,00,000 (Rupees Fifty Crore only) being 50% of Fund out of Budget Allocation of Rs.100 Crore for the implementation of Namakku Naame Thittam (NNT) for the year 2021-2022 and to release a sum of Rs.48,75,00,000/- (Rupees Forty Eight Crore and Seventy Five Lakh only) (i.e.) after adjusting the

unspent balances available in the Namakku Naame Thittam (NNT) bank accounts of Director of Rural Development and Panchayat Raj.

4. The amount sanctioned in para 3 above, shall be debited to the following Head of account:-

“2515-00-Other Rural Development Programmes – 102- Community Development – State’s Expenditure – AU - Implementation of Namakku Naame Thittam 309-Grants-in- Aid – 03 - Grants for Specific Schemes. (DPC 2515-00-102-AU-30903)

5. The Director of Rural Development and Panchayat Raj is authorized to draw the amount sanctioned in para 3 above and disburse the same to the Districts (except Chennai) and send the progress report on the implementation of the Namakku Naame Thittam (NNT) for the year 2021-2022, to the Government.
