Announcement – Hon'ble Chief Minister's Announcement under Rule 110 in the Floor of the Tamil Nadu Legislative Assembly - Schemes – State Scheme – National Bank for Agriculture and Rural Development (NABARD) – Restoring the damaged infrastructures of the Gaja Cyclone affected Districts at an total estimate cost—of Rs.20053.34 lakh with financial assistance from the National Bank for Agriculture and Rural Development under Rural Infrastructure Development Fund (RIDF) XXV for the year 2019-20 - Administrative Sanction accorded - Orders – Issued.

ORDER:

The Hon'ble Chief Minister has made an announcement under Rule 110 in the floor of the Tamil Nadu Assembly on 10.7.2019 as follows:-

"கஜா புயலினால் கட்டடங்கள், சாலைகள் மற்றும் பாலங்களுக்கு அதிக அளவிலான பாதிப்புகள் ஏற்பட்டன. இதனை கருத்தில் கொண்டு, கஜா புயலினால் பாதிக்கப்பட்ட நாகப்பட்டினம், திருவாரூர், தஞ்சாவூர், புதுக்கோட்டை மாவட்டங்கள் மற்றும் திண்டுக்கல் மாவட்டம் கொடைக்கானல் கோட்டத்திற்குட்பட்ட சேதமடைந்த சாலைகள் மற்றும் பாலங்களில் மறுசீரமைப்புப் பணிகள் 200 கோடியே 53 லட்சம் ரூபாய் மதிப்பீட்டில் மேற்கொள்ளப்படும்".

2) In the letter first read above, the Director of Rural Development and Panchayat Raj has sent a proposal to Government to restore the damaged infrastructures of the Gaja Cyclone affected Districts at an estimate cost of Rs.20053.34 lakh with loan

assistance from the NABARD-RIDF for the year 2018-19. In the letter second read above the Finance Department has forwarded the said proposal to NABARD for sanction of loan under NABARD-RIDF XXV (2019-20).

- 3) In the letter third read above the Assistant General Manager, NABARD, has informed that the RIDF Project Sanctioning Committee (PSC) of NABARD, has sanctioned Rs.15944.25 lakh (i.e) against the total estimated cost of Rs.20053.34 lakh for improvements of 134 Rural roads, reconstruction of retaining walls of 13 roads and construction / reconstruction of 115 rural bridges in 5 Districts of Tamil Nadu under RIDF XXV (2019-20).
- 4) The Government after careful examination, accord administrative sanction for the improvement of 134 rural roads, construction of 115 bridges and reconstruction of retaining walls of 13 roads to restore the damaged infrastructures of the Gaja Cyclone affected Districts at an total estimate cost of Rs.20053.34 lakh with the NABARD's Loan Assistance of Rs.15944.25 lakh under RIDF XXV for the year 2019-20, as annexed to this order. Orders pertaining to financial sanction and release of funds for taking up of the above works under NABARD RIDF XXV will be issued separately.
- 5) The Director of Rural Development and Panchayat Raj is requested to monitor the works closely and to ensure that the quality of works is maintained as per the specifications and norms already in force. The Director of Rural Development and Panchayat Raj is directed to issue a detailed instructions in this regard to the District Collectors concerned. The Director of Rural Development and Panchayat Raj is requested to ensure that the above sanctioned works are not included in any of the other Schemes of Rural Development and Panchayat Raj Department or any other Departments before finalizing Tender.
- 6) Three stages photography of all works (i.e) before, during and after the works are mandatory.
- 7) This order issues with the concurrence of Finance Department vide its U.O. No.32508/DS(RR)/2019, dated: 11.07.2019.
