### ORDER:

In the G.Os. first and second read above, orders have been issued for installation of LED lights replacing the tube lights, with detailed guidelines for tender procedure and technical specification. A State Level Committee was constituted during 2015-2016 to finalize the tender procedure and tender schedule. The State Level Committee had conducted a meeting on 08.02.2016 and finalised the specification and tender document for LED street lighting in the year 2015-16.

2. Now, the Director of Rural Development and Panchayat Raj, in his letter 3<sup>rd</sup> read above, has stated that the District Collectors and Project Directors have raised certain issues with regard to the implementation of existing tender conditions based on the difficulties faced and experience gained in the procurement and installation of LED Street Lights during 2015-2016. The Director of Rural Development and Panchayat Raj has therefore proposed certain modifications in the existing tender document for the purchase of LED Street Lights as follows :

a) *The provision enabling participation of consortium in the tender document for supply of LED street lights may be deleted and the eligibility criteria may be modified to permit the participation of only*

*Manufacturers or Authorised Dealers;*

b) *The criteria to have executed works of similar nature to ascertain the experience of the bidder may be added. Since this is a high value contract, the bidder should have done a work of atleast half of the value of the bids invited for State or Central Government departments, agencies and organisations.*

c) The changes with regard to provision of accessories for mounting the LED light and increasing the length of termination cable may also be incorporated.

3. The Government have examined the proposal of the Director of Rural Development and Panchayat Raj in detail and decided to accept the same and issue the following modifications to the Tender document issued in G.O.(Ms) No.11, Rural Development and Panchayat Raj (SGS-III) Department, dated 25.01.2017 for the purchase of LED Street Lights as follows :-

In case of consortium, the prime bidder should be a manufacturer or an authorized dealer of 20 W LED Street lighting unit. Section I, Clause 3, Page No.15, Qualification of Bidders	-	The Bidder should submit proof for having satisfactorily completed similar type of work of not less than 50% of value of the bid under a single agreement for State or Central Government Departments/ Boards/ Government Undertakings / Local bodies.
