ORDER:

In the Government Order first read above, orders were issued for administrative sanction of a sum of Rs.1200 crore towards construction of 60,000/- Solar Powered Green Houses under Chief Minister's Solar Powered Green House Scheme for the year 2015-16 and a sum of Rs.252 Crore was released. In the above order, a detailed guidelines for implementation of the scheme were also issued.

2. In the Government Order second read above, sanction was accorded for the release of Rs 112,29,09,047/- under Chief Ministers Solar Powered Green House Scheme, for the year 2015-16.

3. In the letter 3rd read above the Director of Rural Development and Panchayat Raj has informed that, out of Rs.112,29,09,047/- sanctioned in

the Government Order second read above, a sum of Rs.100 Crore had been released to districts and balance of Rs 12.29 Crore had been released TEDA. As such he has requested to release a sum of Rs.124.58 Crore to settle the hills to the beneficiaries under Chief Ministers Solar Powered Green House Scheme for the year 2015-16, who have constructed their houses under the scheme amidst much hardships and thereby completed the scheme successfully.

4. The Government have examined the proposal of the Director of Rural Development and Panchayat Raj in detail and accept the proposal and to accord sanction and release a sum of Rs.124.58 Crore (Rupees One Hundred and twenty four crore fifty eight lakh only) under Chief Minister's Solar Powered Green House Scheme for the year 2015-16. The sanctioned amount above shall be debited under the following Heads of Account:-
