ORDER :

In the Government Order first read above, orders along with detailed Guidelines were issued for the implementation of Tamil Nadu Village Habitations Improvement (THAI) Scheme during 2013-14. The Government have also accorded sanction for a sum of Rs.750.00 crore towards implementation of Tamil Nadu Village Habitations Improvement (THAI) Scheme during 2013-14 as under:-

2. Out of the financial sanction of Rs.750 crore, from the state fund of Rs.394.36 crore, a sum of Rs.197.18 crore was released in the Government Order first read above.

3. In the Government Order 2nd read above, the Government, among others, have issued orders by increasing the allotment of Pooled Assigned Revenue (PAR) from Rs.111.26 crore to Rs.156.61 crore.

4. In the letter third read above, the Director of Rural Development and Panchayat Raj has stated that, out of the financial allocation from the state fund, the Government had already released a sum of Rs.197.18 crore as 1st installment for implementation of Tamil Nadu Village Habitations Improvement (THAI) Scheme for the year 2013-14 and the same has been released to the districts. Hence, he had requested the Government to release the balance fund of Rs.151,82,38,000 from the state fund, so as to release to the districts for implementation of Tamil Nadu Village Habitations Improvement (THAI) Scheme for the year 2013-2014.

5. After careful examination, the Government has now decided to release further a sum of Rs.151.82 crore from the state fund under Tamil Nadu Village Habitations Improvement (THAI) Scheme apart from the funds released in the Government Order first read above.

6. The amount sanctioned in para 5 above shall be debited under the following Heads of Account:-

- (i) 4515-00-Capital outlay on other Rural Development Programmes - 789 – Special Component Plan for Scheduled Castes - Schemes in the Twelfth Five Year Plan – II State Plan – JE – Tamil Nadu Village Habitation Improvement Scheme (THAI) – 16 major works.
