### **ORDER:**

The Hon'ble Chief Minister while replying to the call attention on the floor of the Legislative Assembly on 29.04.2013, has announced, among others, that houses shall be constructed under CMSPGHS to those people who have lost their houses in the Marakanam riots in Villupuram District.

2) Pursuant to the above announcement, in the letter second read above, the Director of Rural Development and Panchayat Raj has sent a proposal for construction of 11 houses under CMSPGHS 2013-2014 for the fire affected victims of Marakanam Riots in Villupuram District on 25.04.2013. The Director of Rural Development and Panchayat Raj has stated that the victims are residing in Town Panchayat area and the Chief Minister's Solar Powered Green House Scheme is being implemented only in

rural areas and the beneficiaries should find a place in the Below Poverty Line (BPL) permanent list of the Village Panchayat. He has also stated that all the 60,000 houses sanctioned under the CMSPGHS 2013-2014 have been distributed to the Districts and the works are in progress after finalization of beneficiaries and further requested the Government that an amendment to the existing Guidelines of the Chief Minister's Solar Powered Green House Scheme may be issued as a special case so as to take-up the construction of 11 houses to the families affected by the riots in Marakanam Town Panchayat, through the Block Development Officer, Marakanam Panchayat Union and provision of additional funds for construction of these 11 houses.

3) The Government have examined the proposal of the Director of Rural Development and Panchayat Raj in detail. Based on the Announcement made by the Hon'ble Chief Minister and the plight of the fire affected victims, the Government has decided to accept the proposal of the Director of Rural Development and Panchayat Raj and accordingly pass the following orders :-

- a) As announced by the Hon'ble Chief Minister, 11 houses shall be constructed for the fire affected victims in riots on 25.04.2013 at Marakanam Town Panchayat in Villupuram District under Chief Minister's Solar Powered Green House Scheme 2013-2014 in addition to the regular allotment made for the year 2013-2014, after relaxing the relevant clause "People living Below Poverty Line in rural areas are eligible for Solar Powered Green Houses" indicated in the Guidelines issued in the Government Order first read above, as a special case.
- b) Sanction is hereby accorded for a sum of Rs.23.1 lakh towards the construction of the above 11 houses at the unit cost of Rs.2.1 lakh (Rs.1.8 lakh for construction component and the balance amount of Rs.30,000/- for installation of Solar Powered Home Lighting System by Tamil Nadu Energy Development Agency)
- c) The above sanctioned amount of Rs.23.1 lakh shall be met out from the savings in the amount paid out to Tamil Nadu Energy Development Agency (TEDA) for installation of Solar Powered Home Lighting Systems under Chief Minister's Solar Powered Green House Scheme.
- d) The above 11 houses shall be constructed through the Block Development Officer (B.P), Marakanam Panchayat Union, Villupuram District.

4) On receipt of the amount sanctioned in para 3 (b) above from the Tamil Nadu Energy Development Agency (TEDA), the Director of Rural Development and Panchayat Raj is authorized to release the funds to the

Villupuram District at the rate of Rs.1,80,000/- per house and the balance amount at the rate of Rs.30,000/- per house shall be deposited with the Chairman & Managing Director, Tamil Nadu Energy Development Agency, for the purchase and installation of materials relating to Solar Powered Home Lighting Systems.

5) The Director of Rural Development and Panchayat Raj is requested to start the works for construction of houses and to furnish progress report to Government periodically.

6) This order issues with the concurrence of Finance Department vide its U.O. No.3515/FS/P/2013, dated 6.09.2013.
