I am to invite your attention to the references cited and to state that in the Government order first cited, Administrative sanction was accorded for construction of 10,000 Solar Powered Green Houses for weavers by the Handloom, Handicrafts, Textiles & Khadi Department and in the G.O. second cited, orders have been issued for the financial sanction and sanctioning of 60,000 houses to be taken up by the Rural Development and Panchayat Raj Department for the year 2014-15 along with the detailed guidelines under Chief Minister's Solar Powered Green House Scheme (CMSPGHS). In the reference sixth cited, the Handlooms, Handicrafts, Textiles and Khadi Department clarified that construction of 10,000 houses for

weavers, as ordered in Government order 1st cited, the Rural Development and Panchayat Raj Department is entrusted with construction of houses and implementing the scheme and the funds for solar power component are drawn by Director of Rural Development and Panchayat Raj and will be released to Tamil Nadu Energy Development Agency(TEDA) by him.

- 2. In the reference 8th cited, Chairman and Managing Director, Tamil Nadu Energy Development Agency (TEDA) has requested to issue work orders to the vendors for 10,000 Solar Home lighting systems for weavers house.
- 3. In this connection, I am to inform that the Government have examined the proposal sent in the ref 8th cited and after accepting the recommendations of the Empowered Committee constituted under the Chairmanship of the Chief Secretary to Government, the Government approve the following items of work in respect of installation of the Solar Powered Home Lighting System under the Chief Minister's Solar Powered Green House Scheme for weavers.

<u>Supply, Installation and Commissioning of CFL and LED based Solar Home Lighting Systems for weavers</u>

- i. According approval for issuing work orders with the following vendors for Supply, Installation and Commissioning of CFL based Solar Home Lighting Systems under Chief Minister's Solar Powered Green House Scheme for weavers.
 - a) M/s. Mahima Technologies Pvt Ltd., Salem for 841 Nos. covering 6 districts for a total cost of Rs.1,84,63,314/- @ Rs.21,954/- per system.
 - b) M/s. Abhi Energy Pvt Ltd., Chennai for 654 Nos. covering 2 districts for a total cost of Rs.1,43,57,916/- @ Rs.21,954/- per system.
 - c) M/s. Jackson Engineers Limited, Noida for 67 Nos. covering 2 districts for a total cost of Rs.14,70,918/- @ Rs.21,954/- per system.
 - d) M/s. UM-Green Lighting Pvt Ltd., Haryana for 748 Nos. covering 5 districts for a total cost of Rs.1,64,21,592/- @ Rs.21,954/- per system.
- ii. According approval for placing orders with the following venders for Supply, Installation and Commissioning of LED based Solar Home Lighting Systems under Chief Minister's Solar Powered Green House Scheme for weavers.
 - a) M/s. Servotech Power Systems Ltd., Delhi for 607 Nos. covering 2 districts for a total cost of Rs.89,14,402/- @ Rs.14,686/- per system.
 - b) M/s. Digiflic Controls India Pvt Ltd., Bangalore for 3,763 Nos. covering 5 districts for a total cost of Rs.5,52,63,418/- @ Rs.14,686/- per system.
 - c) M/s. BNK Energy Alternatives., New Delhi for 1,385 Nos. covering 2 districts for a total cost of Rs.2,03,40,110/- @ Rs.14,686/- per system.
 - d) M/s. Solar Quest LLP., Chennai 79, for 1,489 Nos. covering 1 district for a total cost of Rs.2,18,67,454/- @ Rs.14,686/- per system.
 - e) M/s. Mahima Technologies Pvt Ltd., Salem, for 446 Nos. covering 3 districts for a total cost of Rs.65,49,956/- @ Rs.14,686/- per system.
- 4) I am also to request you to take necessary follow-up action and to send an Action Taken Report to Government on placing of orders with regard to installation of Solar Powered Home Lighting Systems for weavers under Chief Minister's Solar

Powered Green House Scheme for weavers (CMSPGHS) and to send progress report with regard to the installation of Home Lighting System periodically to Government.
