## ORDER:

In the Government Order first read above, administrative sanction was accorded for laying/upgradation of 185 rural roads in 31 districts with the financial assistance from NABARD under the Rural Infrastructure Development Fund (RIDF) – XIX to the value of Rs.100 crore.

2) In the letter second read above, the Director of Rural Development and Panchayat Raj has sent a proposal to be forwarded to the NABARD for release of start-up advance of Rs.16.00 crore under NABARD - RIDF XIX. (20% of loan amount of Rs.80.00 crore)

- 3) In the letter 3<sup>rd</sup> read above, the NABARD among others has accorded a sanction of Rs.16.00 crore towards start-up advance under NABARD RIDF XIX.
- 4) In the light of the sanction accorded by the NABARD towards start-up advance under NABARD RIDF XIX and after examining the proposal of the Director of Rural Development and Panchayat Raj, the Government accord sanction and release of Rs.16.00 crore (Rupees Sixteen crore only) for laying/upgradation of rural roads, under NABARD RIDF XIX, as start up advance.
