State Schemes - Rural Development and Panchayat Raj Department – Introduction of Tamil Nadu Rural Roads Improvement Scheme (TNRRIS) 2015-2016 – Inclusion of one clause in the Guidelines – Addendum – Issued.

ORDER:

In the Government Order 1st read above, the new Comprehensive Road Scheme called Tamil Nadu Rural Roads Improvement Scheme (TNRRIS) 2015-2016 was introduced. Detailed Guidelines were also issued for the New Scheme.

2. In the letter 2nd read above the Director of Rural Development and Panchayat Raj has stated that Under Para 6 (VIII) of the guidelines for the TNRRIS, it has been specified that roads passing through / on PWD Channel, other water bodies like Ooranies, Kanmai and Tank bund should not be proposed. Whereas it has been brought to the notice of that, in some Districts there are many roads which are falling under the above category and these could not be proposed under TNRRIS as per the guidelines of the scheme. Hence, in order to include these roads for Upgradation / Improvement under TNRRIS, the following clause may be added after para 6 (VIII).

"In case of a road passing on / over tank bunds and proposed for Upgradation / Improvement, the Project Director (DRDA) and Executive Engineer (RD) shall inspect the road. Based on the importance and utility of the roads detailed proposals shall be submitted along with necessary photographs etc., to the Director of Rural Development. In case of roads passing on / over PWD tank bund or PWD channel, "no objection Certificate" should be obtained from PWD and the same shall be submitted to Director of Rural Development along with the proposal. The Director of Rural Development will accord approval on a case by case basis after detailed scrutiny".

3. The Director of Rural Development and Panchayat Raj has therefore requested the Government to issue necessary orders for the inclusion of the above clause after para 6 (VIII) as addendum.

4. The Government after careful examination of the proposal of Director of Rural Development and Panchayat Raj at para 3 above, issue the following Addendum to the Guidelines issued in G.O.(Ms)No.81, Rural Development and Panchayat Raj (SGS2) Department, dated 24.05.2015.

Addendum

The following clause shall be added after para 6 (VIII) as para 6 (IX).

"In case of a road passing on / over tank bunds and proposed for Upgradation / Improvement, the Project Director (DRDA) and Executive Engineer (RD) shall inspect the road. Based on the importance and utility of the roads detailed proposals shall be submitted along with necessary photographs etc., to the Director of Rural Development. In case of roads passing on / over PWD tank bund or PWD channel, "no objection Certificate" should be obtained from PWD and the same shall be submitted to Director of Rural Development along with the proposal. The Director of Rural Development will accord approval on a case by case basis after detailed scrutiny".

The existing para 6 (IX) and 6 (X) shall be renumbered as para 6 (X) and 6 (XI) respectively.

7. This order issues with the concurrence of the PWD and Finance Departments vide their U.O.No.19/Prl.Secy/PWD/2015, dated 16.06.2015 and U.O.No.2766/FS/P/15, dated 17.06.2015 respectively.
