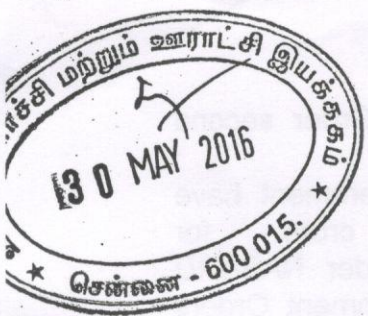

ORDER:

In the Government Order first read above, Administrative Sanction was accorded for laying /upgradation of 590 rural roads and construction of 26 bridges with financial assistance from the NABARD under the Rural Infrastructure Development Fund – XX (RIDF- XX) - to the value of Rs.339.9071 crore.

2. In the Government Order second read above, the Government have accorded sanction and release of Rs.54,38,50,000/- for laying/up gradation of rural roads and construction of bridges under NABARD-RIDF XX as start up advance.

3. In the Government Order third read above, the Government have accorded further financial sanction and release of Rs.45,61,50,000/- for laying/upgradation of rural roads and construction of bridges under NABARD

RIDF XX apart from the funds already released in the Government Order second read above.

4. In the Government Order fourth read above, the Government have accorded further financial sanction and release of Rs. 100 crore for laying/upgradation of rural roads and construction of bridges under NABARD RIDF-XX apart from the funds already released in the Government Orders second and third read above.

5. In the letter fifth read above, the Director of Rural Development and Panchayat Raj has requested the Government to release an amount of Rs.100.00 crore.

6. The Government have examined the proposal of the Director of Rural Development and Panchayat Raj, in detail and have decided to accept the same. Accordingly, the Government accord further financial sanction and release of Rs.100.00 crore (Rupees One Hundred crore only) for laying/upgradation of rural roads and construction of bridges under NABARD-RIDF XX.
