### **ORDER:**

In the Government Order first read above, Administrative Sanction was accorded for laying /upgradation of 590 rural roads and construction of 26 bridges with financial assistance from the NABARD under the Rural Infrastructure Development Fund – XX to the value of Rs.339.9071 Crore.

2. In the Government Order second, third, fourth and fifth read above, the Government have accorded sanction and release of Rs.54,38,50,000/-, Rs.45,61,00,000/-, Rs. 100 Crore and Rs. 100 Crore respectively for laying/up gradation of rural roads and construction of bridges under NABARD-RIDF XX.

3. In the Government Order sixth read above, administrative sanction was accorded for improvements of 193 Village Panchayats and Panchayat Union Roads in

31 districts at an estimated cost of Rs.103.1320 Crore and construction of 41 numbers of bridges in 11 districts at an estimated cost of Rs.59.6261 Crore with financial assistance from the NABARD under the Rural Infrastructure Development Fund (RIDF- XXI).

4. In the letter seventh read above, the Government have accorded sanction and release of Rs. 26.02 Crore under NABARD-RIDF XXI as start up advance.

5. The Director of Rural Development & Panchayat Raj in the letter eighth read above, has sent proposal to Government for releasing balance amount of Rs. 17378.39 lakhs [ Rs. 3960.58 Lakh towards NABARD-RIDF XX (2014-15) + Rs. 13417.81 Lakh towards NABARD-RIDF XXI (2015-16) ]

6. The Government, after detailed examination of the proposal of the Director of Rural Development and Panchayat Raj, accord sanction and release a sum of Rs. 64.236 Crore [i.e., Rs. 39.6058 Crore towards NABARD-RIDF XX (2014-15) + Rs. 24.6302 Crore towards NABARD-RIDF XXI (2015-16) under NABARD RIDF].
