ORDER:

In the Government Order first read above, administrative sanction was accorded for improvement of 193 Village Panchayats and Panchayat Union Roads in 31 districts at an estimated cost of Rs.103.1320 Crore and construction of 41 bridges in 11 districts at an estimated cost of Rs.59.6261 Crore with Financial Assistance from the NABARD under the Rural Infrastructure Development Fund (RIDF- XXI).

2. In the Government Order second and third read above, the Government have sanctioned to release of Rs.26.02 Crore and 24.6302 Crore respectively for improvement of 193 Village Panchayats and Panchayat Union Roads and construction of 41 bridges under NABARD-RIDF XXI. In letter fourth read above NABARD was addressed for deletion of two works at an estimated cost of Rs.2.56 Crores.

3. In the letter fifth read above, the Director of Rural Development and Panchayat Raj has stated that as on date out of 232 works under NABARD XXI, 198 works (85%) have been completed and the remaining 34 works are in advanced stages of progress. He has therefore requested to release of balance amount of Rs.109.5479 Crore under NABARD – RIDF XXI for the year 2015-16.

4. The Government, after detailed examination of the proposal of the Director of Rural Development and Panchayat Raj, release a sum of Rs.109.5479 Crore (Rupees One Hundred and Nine Crore, Fifty Four Lakh and Seventy Nine Thousand only) under NABARD-RIDF XXI (2015-16). The Director of Rural Development and Panchayat Raj is requested to take necessary action for reimbursement of this amount from the NABARD to Government.

5. The amount sanctioned in Para 4 above, shall be debited to the following Heads of Account:-




