



## ABSTRACT

Schemes – State Scheme – National Bank for Agriculture and Rural Development (NABARD) – Improvements of 193 Village Panchayats and Panchayat Union Roads in 31 districts at an estimated cost of Rs.103.1320 Crore and construction of 41 nos. of bridges in 11 districts at an estimated cost of Rs.59.6261 Crore with financial assistance from the NABARD under the Rural Infrastructure Development Fund– XXI - Administrative Sanction accorded- Release of startup advance of Rs.26.02 Crore - Orders – Issued.

### ORDER:

In the Government Order first read above, administrative sanction was accorded for improvements of 193 Village Panchayats and Panchayat Union Roads in 31 districts at an estimated cost of Rs.103.1320 Crore and construction of 41 numbers of bridges in 11 districts at an estimated cost of Rs.59.6261 Crore with financial assistance from the NABARD under the Rural Infrastructure Development Fund (RIDF- XXI).

2) In the letter second read above, the Director of Rural Development and Panchayat Raj, has sent a proposal to be forwarded to the NABARD for release of startup advance of Rs.26.02 Crore under NABARD-RIDF XXI.

3) The start up advance of Rs.26.02 Crore had already been released from NABARD under RIDF- XXI.

4. In the light of the above said position and after examining the proposal of the Director of Rural Development and Panchayat Raj, the Government accord sanction and release a sum of Rs.26.02 Crore (Rupees Twenty Six Crore and two lakhs only) for improvements of rural roads and construction of bridges under NABARD-RIDF XXI as start up advance.

5. The amount sanctioned in para 4 above, shall be debited to the following Heads of Account:-

However, this expenditure shall be brought to the notice of the Legislature by Specific Inclusion in the Supplementary Estimate 2016-2017. Pending provision of such funds, the Director of Rural Development and Panchayat Raj authorized to draw and disburse the amount sanctioned in para 4 above. He is also directed to include this item of expenditure while sending the budget proposal for FMA 2016-17 and also send necessary draft explanatory note for inclusion of this expenditure in the Supplementary Estimate 2016-2017 to Government in Finance (BG.I/RD) Department at the appropriate time without fail.


