ORDER:

In the Government Order first read above, administrative sanction was accorded for Construction / reconstruction of 51 bridges at an estimated cost of Rs.60.9530 Crore with financial assistance from the NABARD under the Rural Infrastructure Development Fund (RIDF- XXII).

- 2. In the letter second read above, the Director of Rural Development and Panchayat Raj has sent proposal to Government to forwarded the proposal to NABARD for release of start-up advance of Rs.9.744 Crore under NABARD-RIDF XXII.
- 3. The start up advance of Rs.9,74,39,800 has been sanctioned and released from NABARD under RIDF- XXII.
- 4. In the light of the above said position and after examining the proposal of the Director of Rural Development and Panchayat Raj, the Government accord sanction and release a sum of Rs.9,74,39,800 (Rupees nine crore and seventy four lakh and thirty nine thousand and eight hundred only) for the Construction / reconstruction of 51 bridges under NABARD-RIDF XXII as start up advance.
