### ORDER:

In the Government Order first read above, administrative sanction was accorded for Laying / upgradation of 187 rural roads and Construction of 7 bridges in 8 flood affected districts at an estimated cost of Rs. 150.00 Crore with financial assistance from the NABARD under the Rural Infrastructure Development Fund (RIDF- XXII).

2. In the letter second read above, the Director of Rural Development and Panchayat Raj has sent proposal to Government to forward the proposal to NABARD for release of start-up advance under NABARD-RIDF XXII.

3. The start up advance of Rs.23,85,94,200/- has been sanctioned and released from NABARD under RIDF- XXII.

4. In the light of the above said position and after examining the proposal of the Director of Rural Development and Panchayat Raj, the Government accord sanction and release a sum of Rs. 23,85,94,200/- (Rupees Twenty three Crore and eighty five lakh and ninety four thousand and two hundred only) as start up advance under NABARD RIDF.




