#### ORDER:

The Director of Rural Development and Panchayat Raj in the letter first read above has sent an additional proposal under NABARD-RIDF XXII for laying / upgradation of 55 rural roads in Salem, Coimbatore, Nammakkal Districts at an estimated cost of Rs. 40.0050 Crore and in the letter second read above Finance Department forwarded the said proposal to NABARD for sanction of loan under NABARD-RIDF XXII.

2) The Assistant General Manager, NABARD, in the letter third read above has informed that the RIDF Internal Sanctioning Committee (ISC) of NABARD, among other things has accorded sanction for laying / upgradation UU1 4U11 41.13

of 55 rural roads at an estimated cost of Rs. 40.0050 Crore under NABARD-RIDF XXII 2016-17.

- 3) Consequent to the sanction accorded by the NABARD in the letter 3<sup>rd</sup> read above, the Government after careful examination, accord administrative sanction for Laying / upgradation of 55 rural roads in Salem, Coimbatore, Nammakkal Districts at an estimated cost of Rs.40.0050 crore with loan assistance from the NABARD under Rural Infrastructure Development Fund-XXII (RIDF-XXII) as annexed to this order. In respect of laying / upgradation of 55 rural roads at an estimated cost of Rs. 40.0050 Crore, out of total Project cost of Rs.40.0050 crore, the NABARD'S loan component would be 80% of the total value and the State Government's share would be 20% of the total value. Orders pertaining to financial sanction and release of funds for taking up the above works under NABARD –RIDF XXII will be issued separately.
- 4) The Director of Rural Development and Panchayat Raj is requested to closely monitor the works and ensure that the quality of works is maintained as per the specifications and norms already in force. In this regard, detailed instructions should be given to the concerned District Collectors by the Director of Rural Development and Panchayat Raj. The Director of Rural Development and Panchayat Raj is also requested to ensure that any of the above sanctioned works are not included in any of the other Schemes of Rural Development and Panchayat Raj Department or any other Departments before finalizing tender.
