ORDER:

In the Government Order first read above, administrative sanction was accorded for Laying / upgradation of 187 rural roads and Construction of 7 bridges in 8 flood affected districts at an estimated cost of Rs. 150.00 Crore with financial assistance from the National Bank for Agriculture and Rural Development (NABARD) under the Rural Infrastructure Development Fund (RIDF- XXII).

2) In the Government Order second read above, Government have accorded administrative sanction and released a start-up advance of Rs.23,85,94,200/- under NABARD-RIDF XXII.

3) In the Government Order third read above, the Government have sanctioned and released a sum of Rs.6.400 Crore towards NABARD-XXII for the year 2016-17.

4) In the letter fourth read above, the Director of Rural Development and Panchayat Raj has sent a proposal to Government to sanction and release of the

balance amount to the tune of Rs.60,19,18,200/- under Budget Estimate for the year 2017-18 for NABARD – RIDF XXII, out of the Budget Estimate of Rs. 200.00 Crore for the year 2017-18.

5) In light of the above said position and after examining the proposal of the Director of Rural Development and Panchayat Raj, the Government accord sanction and release a sum of Rs.60,19,18,200/- (Rupees Sixty Crore Nineteen Lakh Eighteen Thousand and Two Hundred only) for NABARD RIDFXXII, out of Rs. 200.00 Crore under Budget Estimate for the year 2017-18.

6) The amount sanctioned in para 5 above, shall be debited to the following Heads of Account:-
