ORDER:

In the Government Order first read above, administrative sanction was accorded for improvement of 509 Rural Roads in 29 Districts and construction of 40 bridges in 7 Districts at an estimated cost of Rs.316.3249 Crores with financial assistance from the NABARD under the Rural Infrastructure Development Fund (RIDF- XXIII).

2. In the letter second read above, the Director of Rural Development and Panchayat Raj has requested the Government to release the start-up advance of Rs.50.6118 Crore (being 20%) against the NABARD loan component of Rs.253.0592 Crore under NABARD – RIDF XXIII for the year 2017-18.

3. The Government, after detailed examination of the proposal of the Director of Rural Development and Panchayat Raj, release a sum of Rs. 50.00 Crore under NABARD-RIDF XXIII (2017-18) out of the RE of Rs.250.00 Crore for the year 2017-18. The Director of Rural Development and Panchayat Raj is directed to take necessary action for reimbursement of this amount from the NABARD to Government.

4. The amount sanctioned in para 3 above, shall be debited to the following Heads of Account:-
