ORDER:

In the Government Order read above, orders were issued launching the Housing Scheme called Samathuvapuram by Government of Tamil Nadu in the year 1997-98 to promote the social justice and spread Thanthai Periyar's message of social equality. During the period from 1997 to 2001, 145 Samathuvapurams and during the period from 2008-2011, 93 Samathuvapurams totally 238 Samathuvapurams were established in rural areas of Tamil Nadu in which all the communities live with unity and brotherhood and share all basic infrastructure and the amenities without any discrimination.

2. The Hon'ble Chief Minister of Tamil Nadu has made the following Announcement on the Floor of Legislative Assembly on 24.06.2021, while replying to the debate on Governor's Address:-

"ஏற்றத்தாழ்வை இடித்து, சமூகத்தை சமப்படுத்த போராடிய தந்தை பெரியார் பெயரால் 240 சமத்துவபுரங்களை கட்டினார் முத்தமிழறிஞர் தலைவர் கலைஞர் அவர்கள், அந்த சமத்துவபுரங்கள் சரியாக பராமரிக்கப்படாத அவல நிலையில் இப்போது இருக்கின்றன. அந்த சமத்துவபுரங்கள் உடனடியாக சீரமைக்கப்படும்".

3. Further, in continuation to the above Announcement, on 24.08.2021 the Hon'ble Minister for Rural Development has made the following Announcement:-

"24.06.2021 அன்று நடைபெற்ற ஆளுநர் உரை மீதான விவாதத்திற்கு பதில் அளிக்கும் போது, மாண்புமிகு முதலமைச்சர் அவர்கள் ஏற்கனவே கட்டப்பட்டுள்ள சமத்துவபுரங்கள் சீரமைக்கப்படும் என அறிவித்ததன் தொடர்ச்சியாக, ஏற்கனவே கட்டப்பட்டுள்ள பழைய சமத்துவபுரங்களை சீரமைப்பதற்காக, பழைய வீடுகளை பழுதுபார்த்தல், குடிநீர் விநியோகப் பணிகள், தெருவிளக்கு பராமரிப்பு, விளையாட்டு மைதானம், பூங்கா பராமரிப்பு, தந்தை பெரியாரின் சிலை பராமரிப்பு போன்ற பராமரிப்புப் பணிகள் படிப்படியாக மேற்கொள்ளப்படும்".

4. In the letter third read above, the Director of Rural Development and Panchayat Raj has sent the revised proposal for repair / reconstruction of 149 old Samathuvapurams out of 238 Samathuvapurams stating that in the last 10 years, these Samathuvapurams have not been maintained properly and no funds have been allocated for repairing the houses and the improvement/maintenance of infrastructure facilities like Street Lights, Water Supply, Internal Streets and approach Road to Samathuvapuram, Public Distribution Shops and other infrastructure facilities created in the Samathuvapurams.

5. He has further stated that in each Samathuvapuram, 100 houses were constructed with a separate Toilet and basic infrastructure facilities like street lights, water supply with OHT, BT/CC Roads and Public Distribution Shop were also provided. Houses were allotted among the beneficiaries belonging to different communities by a Selection Committee headed by Project Director, DRDA with Block Development Officer, Tahsildar, Village Administrative Officer, Village Panchayat President and Member of the Panchayat Level Federation of the SHGs as Member in the proportion SC:BC:MBC: Others as 40:25:25:10 respectively so as to ensure that beneficiaries belongs to all communities live with social harmony. To provide a facelift to these Samathuvapurams and to provide better living environment for the people living here, Government has decided to repair and renovate the Samathuvapurams including Houses and common infrastructure/basic facilities in the Samathuvapurams established during 1997 to 2011 in two phases.

6. He has further stated that based on the Announcement made by the Hon'ble Chief Minister of Tamil Nadu and the Hon'ble Minister for Rural Development, the present condition of all 238 Samathuvapurams have been surveyed by the Districts and detailed proposal for the renovation of Samathuvapurams along with estimates have been received from the Districts as follows:-

➤ **Implementing Agency**

At present, out of 238 Samathuvapurams 15 Samathuvapurams fall in Urban areas. The renovation of all 238 Samathuvapurams including the 15 located in Urban areas will be done by the Rural Development and Panchayat Raj Department.

➤ **Repair/Reconstruction of Houses**

During 1997-2001, 14,502 Houses were constructed in 145 Samathuvapurams and during 2008 to 2011, 9228 Houses were constructed in 93 Samathuvapurams. Totally, 23,730 houses (only 50 houses constructed in Kadalangkudi Samathuvapuram, 78 houses in Tholar Samathuvapuram and 102 houses constructed in Karumathur Samathuvapuram) were constructed in all 238 Samathuvapurams. Out

of the 23,730 houses, 23,252 houses have been allotted to beneficiaries. The remaining 478 houses in 5 Samathuvapurams have not been allotted to beneficiaries due to various reasons.

The repair/reconstruction of houses and repairs to infrastructure facilities in 145 Samathuvapurams is proposed to be taken up in the first Phase during 2021-22. Further, out of the 5 un-allotted Samathuvapurams, the one Samathuvapuram constructed in Kozhuvuri Village Panchayat of Vanur Block in Villupuram District has been completed recently and ready for allotment to the eligible beneficiaries. Apart from this, the improvements to the 4 Samathuvapurams (one each in Tiruvallur, Cuddalore, Trichy and Sivagangai Districts) established during the period 2008-2011 and not allotted to the beneficiaries is also proposed to be taken up during the year 2021-22 as a special case to allot houses in the Samathuvapurams to the beneficiaries. The details are as mentioned below:-

➤ **Nature of Repairs and Unit cost**

The Samathuvapuram houses have been categorised based on their existing condition and the nature of repairs required. The cost required has been worked out accordingly. These details are summarised below:

➤ **Estimate of Repair and Mode of Execution**

As indicated above all the Samathuvapuram Houses have been allocated to the beneficiaries except 478 houses. It is proposed to take up minor repairs and General Maintenance (Sl.No.5 and 6 of Table-2) of houses through the concerned beneficiaries at an average cost of Rs.50,000 per house, which will be a onetime financial assistance for the repair of houses. Also, based on the survey it is seen that about 436 houses have been abandoned out of the 23,252 Houses allotted to beneficiaries. The repair of abandoned houses and all reconstruction works (Sl.No.1 to 4 of Table-2) will be done by the Department through Contractor as per actual estimated cost. The mode of execution, funds required and funding source for repair/reconstruction of houses are as given below:-

The abandoned Houses will be allotted to fresh beneficiaries following the Samathuvapuram Guidelines for selection of beneficiaries. The identification of beneficiary and allotment will be done before the repair works are started by the Department.

In cases of all reconstruction works, the beneficiary will be instructed to make alternate arrangements for their stay as is the practice in PMAY(G) till the works are completed. Consent will be obtained from the beneficiaries in a prescribed format.

In case of all contract works, the beneficiary will be asked to monitor the work during construction. Payment to the Contractor will be released after completion form is signed by the beneficiary.

➤ **Repair to Infrastructure**

The improvement of common infrastructure/basic facilities in 145 Samathuvapurams as well as improvements to common infrastructure in 4 unallotted Samathuvapurams is proposed to be taken up in Phase-I during 2021-22. An amount of Rs.50.05 Crore is required for this as detailed below:

➤ **Funding for the Scheme:**

As per G.O. (Ms.) No.42, RD&PR(SGS-1) Dept., dated:26.02.2021, sanction was accorded for the release of Rs.129.55 Crore and the same was drawn. Further, an amount of Rs.22.95 Crore is available as unspent amount pertaining to previous repair to houses scheme and an amount of Rs.2.31 Crore is accrued as interest amount under this scheme. Thus, a total amount of Rs.154.81 Crore is available. In as much as the original sanction was made for the repair of houses constructed under earlier housing programmes, the utilisation of these funds for the repair of Samathuvapuram houses and homestead infrastructure will be within the ambit of the original objective of the Government in sanctioning Rs.129.55 Crore.

7. The Director of Rural Development and Panchayat Raj has therefore requested the Government to issue necessary orders to repair / reconstruction of 14,880 Houses in 149 old Samathuvapurams in Phase-I during the year 2021-2022 and seeking permission to meet out this expenditure from out of the amount of Rs.154.81 Crore available under "Repair to the houses constructed under Government Schemes" and to approve the draft Guidelines in English.

8. The Government have carefully examined the above proposal of the Director of Rural Development and Panchayat Raj in detail and decided to accept the same and issue the following orders:-

- (i) Permission is accorded to cancel the G.O.(Ms.) No.42, Rural Development and Panchayat Raj (SGS-1) Department dated:26.02.2021 related to "Repair to the Houses constructed under Government Schemes" and permission is accorded for utilization of the funds already released under this Government Order for the purpose of repair/reconstruction of Houses in 149 old Samathuvapurams to be taken up during 2021-22 in Phase-I;
- (ii) Financial sanction is accorded to carry out repair/reconstruction of 14,880 Houses in 149 Samathuvapurams (Table-3) in Phase-I during 2021-22 at a total cost of Rs.140.39 Crore as detailed below and permission is accorded to meet out this expenditure from out of the amount of Rs.154.81 Crore available under "Repair to the houses constructed under Government Schemes" as indicated at para 6 above under the caption "Funding for the Scheme".
 - (a) Financial Sanction is accorded for a sum of Rs.61.19 Crore @ Rs.50,000 for each house for carrying out minor repair works in 12,237 Houses (Table 3, Row No.1) as one time financial assistance to beneficiaries and to permit these works to be carried out by the concerned beneficiaries themselves.
 - (b) Financial sanction is accorded for a sum of Rs.79.21 Crore which includes Rs.0.64 Crore for the repair of 99 abandoned houses (Table 3, Row No.2), Rs.3.36 Crore for repair of 378 unallotted houses in 4 Samathuvapurams (Table 3, Row No.4) and for a sum of Rs.75.21 Crore for reconstruction of 2,166 Houses (Table 3, Row No.3) and permission is accorded to repair / reconstruction of 2643

(99+378+2166) houses (occupied/abandoned/unallotted) through contract mode by the concerned Block Development Officer (BP).

- (iii) Financial Sanction is accorded for a sum of Rs.12.77 Crore for improvement to common infrastructure and permission is accorded to meet out this expenditure from out of the amount of Rs.154.81 Crore available under "Repair to the houses constructed under Government Schemes" as indicated at para 6 above under the caption "Funding for the Scheme". Permission is accorded to meet out the expenditure from the 80% devolution component of CGF for water supply and road works at a cost of Rs.35.51 Crore and Rs.1.77 Crore for repair to School Buildings and Toilets for the year 2021-22;
- (iv) Permission is accorded to carry out improvement of common infrastructure/Basic facilities in 145 Samathuvapurams established during 1997-2001 and in 4 unallotted Samathuvapurams established during 2010-11 at a total cost of Rs.50.05 Crore (Table 4).
- (v) Detailed Guidelines for repair/reconstruction of 149 old Samathuvapurams for the year 2021-22 in Phase-I is annexed to this order as Annexure-I and the details of repair/reconstruction works in 149 old Samathuvapurams taken up for the year 2021-22 are annexed to this order as Annexure-II to Annexure-VI.

9. The Director of Rural Development and Panchayat Raj is permitted to utilize the amount sanctioned in para 8(ii) and (iii) above out of the unspent available and by dovetailing funds as contemplated therein and disburse the same to the Districts (except Chennai) and send the progress report on the renovation of old Samathuvapurams during the year 2021-2022, to the Government.

ANNEXURE-I

GUIDELINES FOR REPAIR / RECONSTRUCTION WORKS IN 149 OLD
SAMATHUVAPURAMS IN PHASE-I FOR THE YEAR 2021-2022

1. Introduction

The Government of Tamil Nadu had launched the “Periyar Ninaivu Samathuvapuram” in rural areas in the year 1997-98 to promote social justice and spread Thanthai Periyar’s message of Social equality. Under the scheme, construction of houses and also provision of other civic infrastructure in the habitations were carried out and the houses were allotted among the beneficiaries belonging to different communities. Totally, 238 Samathuvapurams were constructed in two spells, i.e. from 1997-2001 and 2008-2011. Out of this, 5 Samathuvapurams are yet to be allotted to beneficiaries. These Samathuvapurams have not been renovated since their establishment and considering their present status, the Government intends to renovate all Samathuvapurams constructed by Rural Development and Panchayat Raj Department.

The renovation of Samathuvapurams will be taken up in a phased manner:

- a) In Phase-I, 145 Samathuvapurams constructed during 1997-2001 and 4 unallotted Samathuvapurams constructed during 2008-2011 shall be taken up for renovation in the year 2021-22.
- b) In Phase-II, remaining 88 Samathuvapurams constructed during 2008-2011 will be taken up for renovation during the year 2022-23.

2. Objective

The objective of the scheme is to renovate all 238 Samathuvapurams including the 15 located in urban areas. This includes repair/reconstruction of houses and also maintenance of common infrastructure.

3. Category of works

a) Repair/Reconstruction of Houses

- (i) Structural Failure (Below Basement)
- (ii) Damaged Super Structure (Basement)
- (iii) Partly Damaged Super Structure (Sill/Lintel Level)
- (iv) Damaged Roof (Roof Level)
- (v) Minor Repairs - Plastering, Relaying weathering course & Colour Washing and completion
- (vi) General Maintenance - Colour Washing and completion

b) Repair to Infrastructures

- (i) Water Supply
- (ii) Road works

- (iii) Street lights
- (iv) Play grounds
- (v) Parks
- (vi) Periyar Statue (Repairs) & Periyar Statue (New)
- (vii) Community Hall
- (viii) Library
- (ix) Anganwadi
- (x) Public Distribution Shop
- (xi) Periyar Ninaivu Samathuvapuram Arch
- (xii) School Building
- (xiii) School Toilet

4. Allocation of Funds

All reconstruction works mentioned in para 2 a) (i) to (iv) will be taken up as per actual estimated cost.

In respect of Minor Repairs(v) and General Maintenance(vi) an average cost of Rs. 50,000 per house will be provided as one-time assistance to beneficiaries.

5. Mode of Execution

In case of minor repairs, the works will be executed through the concerned beneficiary. The repairs in abandoned houses and all houses requiring reconstruction/relaying of roof will be done by adopting due tender process.

6. Funding

- a) All the repair/reconstruction of 14,880 houses in 149 Samathuvapurams in Phase-I during 2021-22 shall be borne from "Repair to the houses constructed under Government Schemes".
- b) The entire water supply and road works shall be borne from the 80% devolution component of Capital Grant Fund (CGF) 2021-22.
- c) The repair to School Buildings and School Toilets shall be from the 80% devolution component of Capital Grant Fund (CGF) 2021-22.

7. Administrative Sanction

Administrative sanction shall be accorded by the District Collector. The execution of the works shall be entrusted to the Block Development Officer (Block Panchayat).

8. Preliminary steps to be taken up before executing the renovation works

- i) In case of abandoned/un-allotted houses, the eligible beneficiary shall be identified and allotment shall be made before repair works are carried out by the Department.
- ii) In case of reconstruction works, beneficiaries shall be informed prior to commencement of construction for making alternate arrangements for their stay. Consent shall be obtained from the beneficiaries in this regard.

- iii) Payment to the Contractor shall be released only after obtaining completion certificate from the beneficiary.

9. Execution of works

- i) The Union Overseers, Assistant Engineers/Junior Engineers shall be responsible for the renovation of works and other technical aspects.
- ii) The Assistant Executive Engineers shall super check all the works.
- iii) The Project Director, DRDAs, Executive Engineers (RD) and Assistant Executive Engineers (RD) should frequently inspect the progress in the execution of works and ensure its timely completion.

The measurements of work shall be recorded by the Union overseer/Assistant Engineer and the Check Measurement shall be done by the concerned Assistant Engineer / Assistant Executive Engineer(RD) as per the G.O.(Ms.) No.111, Rural Development and Panchayat Raj (PR-1) Department, Dated: 21.08.2018. The Executive Engineer (RD) shall super check the works as per the norms indicated in G.O. (Ms) No. 54, Rural Development and Panchayat Raj (PR.1) Department, dated: 22.05.2014.

- iv) All the mandatory Quality control tests before, during and after execution of the works must be done.
- v) The Block Development Officer(BP), shall call for the tenders for the following works in a Samathuvapuram as a single package to ensure uniformity in implementation:-
 1. Reconstruction of houses
 2. Maintenance of Infrastructure works
 3. Roads pertaining to Samathuvapuram
 4. Drinking Water Supply works.
- vi) After execution of works the BDO (Block Panchayat) concerned shall make payment to the Contractor only after obtaining certificate from beneficiary of the satisfactory completion of works.

10. Monitoring

- i) The District Collector shall review the progress of the renovation works with the Block Officials at regular interval in order to ensure continuous monitoring and for expeditious completion of works.
- ii) The District Collector and the Project Director, District Rural Development Agency is the Officers responsible for the proper implementation of the renovation works in Samathuvapurams at District Level.

11. Avenue Plantation

Raising of avenue plantations shall be done in all Samathuvapurams. Fruit bearing trees, shade trees, timber trees etc. shall be planted along the roadside beyond the outer periphery of the berms so as to avoid cutting of trees in future during widening/improvement of roads. Avenue Plantation shall be done as per IRC-SP-103-2014 (Guidelines for Tree Plantation along Rural Roads) under General Fund or MGNREGS or in co-ordination with the Forest Department under the special scheme for massive tree plantation in non-forest areas.

12. Documentation

Proper documentation of the works should be done capturing various processes in the implementation of the scheme. Photographs of the site before undertaking the work, during execution of the work and after completion of the work should be taken and properly documented and to be submitted to the Directorate.

The Principal Secretary to Government, Rural Development and Panchayat Raj Department is empowered to modify the guidelines of renovation of Samathuvapuram Scheme, whenever necessary, in consultation with the Director of Rural Development and Panchayat Raj.
