In the Government Order first read above, orders were issued for repairs/reconstruction of 14,880 Houses in 149 old Samathuvapurams in Phase-I during the year 2021-2022 along with the detailed Guidelines.

2. In the Government Order second read above, separate guidelines were issued for the execution of renovation work in Samathuvapuram under the category of Sold out/Rented/ Abandoned houses.

3. In the Letter read above, the Commissioner of Rural Development and Panchayat Raj has sent a proposal to Government for amending the guidelines issued in the Government order second read above, under the Para Nos.2.1(b) and 2.2(b) for selection of beneficiaries as "original beneficiary" instead of "present occupant" and requested the Government to issue necessary orders.
