ORDER:

In the Government Order read above, orders were issued for the implementation of School Infrastructure Development Scheme (SIDS) for the year 2021-22 and sanctioned an amount of Rs.115.78 Crore along with the detailed guidelines.

2. In the Letter read above, the Commissioner of Rural Development and Panchayat Raj has stated that the above scheme shall be implemented only in the AGAMT-II Villages selected for the year 2021-22. Based on the above sanction, the funds have been allocated to all the Districts for the implementation of SIDS for the year 2021-22. Accordingly, the District Collectors had accorded administrative sanction for 8,912 works for an amount of Rs.107.04 crore.

3. He has further stated that since the repair and renovation of all Panchayat Union Primary and Middle schools in AGAMT-II (2021-22) Villages are to be covered under SIDS 2021-22 in the saturation mode, among other Districts, 17 Districts have now requested additional funds of Rs.20.09 crore to execute the 1,152 works in the identified AGAMT-II (2021-22) Village Panchayats.

4. He has further stated that the savings amount of Rs.1.68 crore is available in the above Districts from SIDS 2021-22 fund allocation. Hence, the net additional amount required for the saturation of SIDS works in AGAMT-II (2021-22) Villages is worked to Rs.18.41 crore. As on 28.10.2022, an amount of Rs.19.88 crore is available

as savings from the previous Panchayat Union School Renovation Programme and Comprehensive School Infrastructure Development Scheme (CSIDS). Hence, the additional amount of Rs.18.41 crore required to saturate the SIDS works in AGAMT-II (2021-22) Villages may be met out from the above savings.

5. The Commissioner of Rural Development and Panchayat Raj has therefore requested the Government to permit him to utilize the savings amount from the previous Panchayat Union School Renovation Programme and Comprehensive School Infrastructure Development Scheme (CSIDS) for taking up additional 1,152 repair and renovation works in Panchayat Union Primary and Middle Schools to saturate AGAMT-II (2021-22) Villages at an estimated amount of Rs.18.41 Crore

6. The Government have carefully examined the proposal of the Commissioner of Rural Development and Panchayat Raj at para 5 above in detail and decided to issue the following orders:-

- (i) The Commissioner of Rural Development and Panchayat Raj is permitted to utilize the savings amount of Rs.1.68 crore from SIDS (2021-22) and Rs.18.41 crore from the Panchayat Union School Renovation Programme and Comprehensive School Infrastructure Development Scheme (CSIDS) for taking up additional 1,152 repair and renovation works in Panchayat Union Primary and Middle Schools to saturate Anaithu Grama Anna Marumalarchi Thittam-II (2021-22) Villages.
- (ii) The Commissioner of Rural Development and Panchayat Raj is instructed to adhere the guidelines issued under SIDS (2021-22) strictly.

7. The Commissioner of Rural Development and Panchayat Raj is requested to ensure the proper utilization of proposed fund with utilization certificate and to send the periodical progress report to Government.

8. The Commissioner of Rural Development and Panchayat Raj is directed to monitor the works very closely and ensure that the quality of works done as per norms.

9. This order issues with the concurrence of Finance Department vide its U.O. No.51977/Fin(RD)/2022, dated: 12.12.2022.
