ORDER:

In the Government Order first read above, orders were issued according financial sanction for repair/reconstruction of 14,880 Houses in 149 old Samathuvapurams in Phase-I during the year 2021-2022 as per the Announcement made by the Hon'ble Chief Minister of Tamil Nadu and Hon'ble Minister for Rural Development on the Floor of Tamil Nadu Legislative Assembly on 24.06.2021 and 24.08.2021 along with the detailed Guidelines.


