2) In the letter 2<sup>nd</sup> read above, the Director of Rural Development and Panchayat Raj has stated that in the G.O (Ms) No.292, Rural Development and Panchayat Raj Department, dated 14.6.2010 orders were issued among others, to carry out the construction of maintenance sheds, compound walls and concrete flooring for Bus Depots of State Transport undertakings by utilizing the Untied Component of Member of Legislative Assembly Constituency Development Scheme fund.
