### **ORDER:**

In the Government Order first read above, administrative sanction was accorded for laying of 637 Rural Roads in 31 districts of Tamil Nadu to the total value of Rs.315 crore and financial sanction to the tune of Rs.157.50 crore was also accorded and released therein.

2) In the letter second read above, the Commissioner of Rural Development and Panchayat Raj has stated that the requirement of balance amount is Rs.152.80 crore after taking into account the deletion of 7 road works already sanctioned in the Government Order first read above and requested the Government to sanction the above amount since the progress of works is held up and bills could not be settled for want of funds.

3) After careful examination, the Government accord sanction and release a sum of Rs.152.80 crore (Rupees One hundred fifty two crores and eighty lakhs only) under NABARD-RIDF XVII (additional), in addition to the funds released in the Government Order first read above.

4) The amount sanctioned in para 3 above shall be debited under the following Heads of Account:-
