ORDER:-

The Project Director, Pudhu Vaazhvu Project in her letter read above has stated that the Pudhu Vaazhvu Project is one of the key development initiatives of the Government of Tamil Nadu to reduce poverty and empower the rural poor. The Project provides assistance for productive livelihood activities to poor and very poor people in the Village through the Community Driven Development (CDD) approach. The objectives of the Project are to empower the poorest of the poor, the marginalized and the differently abled and to promote sustainable livelihood for them. The Project develops Community Based Organisations (CBOs) and strengthens them, enhances the skills and capacities of the poor and promotes transparent governance and social accountability. To achieve these objectives the Project has adopted key non-negotiable principles.

2. She has further stated that the Project is being implemented in the State from October 2006 onwards with an outlay of Rs.717.10 Crores covering 5.8 lakhs target families in 2509 Village Panchayats covering 70 backward Blocks in 16 districts. The World Bank has sanctioned additional finance for a total sum of Rs.950 Crores and the Government of Tamil Nadu have issued Administrative Sanction for implementation of Project activity in additional 3.82 Lakhs target families in 1665 Village Panchayats covering 46 Blocks in additional 10 districts and 4 Blocks in existing Project areas. The period of implementation of the Project has been extended from September 2011 to September 2016 including existing Project areas.

Component wise Break-up:

4. The Project Director, Pudhu Vaazhvu Project has also stated that the Budget Estimate for the year 2015-16 is Rs.255.04 Crores. She has further stated that the Vote on Account authorizes the department to incur expenditure to the extent of 50% of the Budget Estimate and therefore a sum of Rs.125.00 crores can be released by the Government to meet out the expenditure for implementation of the Project activities.

5. The Project Director, Pudhu Vaazhvu Project has further stated that the project is scheduled to be closed by September, 2016. The time left out from now is 17 months only. Further, the expenditure towards project activities during the last 6 months of the project from April 2016 to September, 2016 will become standstill except expenditure on administrative nature due to the intervention of Legislative Assembly election due in May, 2016. Therefore, the Project is in very crucial juncture to step up the expenditure to the tune of Rs.316.25 crores on or before 31.03.2016, within a period of 11-12 months. Further, the Project machinery has already been geared up to achieve the targeted expenditure. Approximately a sum of Rs.30.00 crores per month has to be incurred per month from April, 2015 to achieve the target. To step up the expenditure, the project plans among other things to take up (i) Pilot activities to the tune of Rs.30.35 crores.

6. The Project Director, Pudhu Vaazhvu Project has therefore requested the Government to issue orders for sanction of Rs.125.00 Crores out of Total B.E. Rs.255.04 Crores under the Pudhu Vaazhvu Project grant for the year 2015-2016. She has also requested the Government to authorize the Director of Rural Development and Panchayat Raj, Chennai to draw and disburse the above amount to the Project Director, Pudhu Vaazhvu Project.

7. The Government, after careful examination of the proposal of Project Director, Pudhu Vaazhvu Project have observed that an amount of Rs.1512.06 crores has already been released out of the approved outlay of Rs.1667.10 crores leaving a balance of Rs.155.04 crores. Whereas an amount of Rs.255.04 crores is estimated as expenditure for the year 2015-16 as provided in the Budget Estimate for 2015-16. The Budget is estimated taking into account the expected exchange rate gain. As on 30.04.2015, an amount of Rs.99.05 crores is available with the Project and the Government accord sanction and release a sum of Rs.60.00 crores (Rupees Sixty crores only) towards the implementation of Pudhu Vaazhvu Project during the year 2015-16 as per the project activities mentioned above.
