ORDER:

The Ministry of Rural Development, Government of India, in its letter first read above has sanctioned Rs.25,34,59,000/- (Rupees Twenty five crores thirty four lakhs fifty nine thousand only) to the State Government towards first instalment of Central share under National Rural Livelihoods Project during the year 2014-15.

2. The Managing Director, Tamil Nadu Corporation for Development of Women Limited in her letter second read above has stated that for the year 2014-15 the Annual Action Plan was approved by the Government of India on 18.02.2014 with the financial outlay of Rs.150.36 crores (NRLM and NRLP).

3. The Managing Director, Tamil Nadu Corporation for Development of Women Limited has further stated that Government of India have sanctioned an amount of Rs.25,34,59,000/- (Rupees twenty five crores thirty four lakhs fifty nine thousand only) to state Government towards 1st instalment of Central share under NRLP during 2014-15 and credited the amount to State Government account and instructed the State Government to release the fund along with the state share immediately to Tamil Nadu State Rural Livelihoods Mission.

4. She has added that In BE 2014-15, a sum of Rs.25648.00 lakhs have been provided under Aajeevika head of account as detailed below.

The Managing Director, Tamil Nadu Corporation for Development of Women Limited has therefore requested the Government to sanction the total amount of Rs.33,79,45,333/- (Rupees Thirty three crores seventy nine lakhs forty five thousand three hundred and thirty three only) (Central share 25,34,59,000/- + State share Rs.8,44,86,333/-) and to authorise the Director of Rural Development and Panchayat Raj to release the amount to TNSRLM.
