- Operation and Maintenance of Water supply, Street lights and Sanitation.
- Payment of Electricity charges for water supply and streetlights.
- 2. In the Government Orders second, third, fourth and fifth read above, the Government sanctioned Thirteenth Finance Commission General Basic Grant of Rs.471.65 crores for the year 2013-14 to the Rural Local Bodies.
- 3. The Director of Rural Development and Panchayat Raj in his letter sixth read above has requested the Government to sanction an amount of Rs.272.975 crores to Rural Local Bodies towards the first instalment of General Basic Grant recommended by the Thirteenth Finance Commission for the year 2014-15.
- 4. The Government has examined the proposal of the Director of Rural Development and Panchayat Raj carefully and accord sanction for the release of Rs.327.57 crores (Rupees Three hundred and twenty seven crores and fifty seven lakhs only) as first instalment of General Basic Grant for the year 2014-15 to Village Panchayats under recommendation of the 13th Finance Commission anticipating the receipt of first instalment grant from Government of India.

The Director of Rural Development and Panchayat Raj is authorized to draw and disburse the amount sanctioned in para 4 above to all Village Panchayats on the basis of 2011 census population and the grant shall be utilized in conformity with the instructions issued in the Government Order first read above. He is also requested to furnish necessary Utilization Certificate towards the utilization of funds sanctioned in para 4 above in order to forward the same to Government of India.
