ORDER :

In the reference sixth cited, the Commissioner of Rural Development and Panchayat Raj has stated that MGNREGS is being implemented in Tamil Nadu in all the 31 Districts and the Labour Budget has increased manifold in recent years when compared to 2006 when the Scheme was started. The allocation for the scheme including administrative cost has gone up from Rs.1722 crore in 2008-09 to Rs.5022 crore in the year 2012-2013. There is a need for strengthening the staff structure at State level so as to ensure proper implementation of the scheme.

2. The Commissioner of Rural Development and Panchayat Raj has also stated that as per the G.O. first read above, the Government had created a State Level NREGA Cell with a view to strengthening the State level organizational capacity in ensuring quality, efficiency and transparency in the implementation of National Rural Employment Guarantee Act (NREGA). Accordingly, the following posts were created for the implementation of the scheme:

3. The Empowered Committee meeting held on 15.02.2013 at New Delhi reiterated need to strengthen the staff strength at state level for better implementation of MGNREGS in Tamil Nadu. The Steering Committee chaired by Chief Secretary to Government in its meeting held on 30.04.2013 approved the strengthening of the State Unit of MGNREGS with the creation of additional posts. Based on the Commissioner of Rural Development and Panchayat Raj has sent the proposal for creation of the following posts at the Directorate of Rural Development and Panchayat Raj.

The Commissioner of Rural Development and Panchayat Raj has further stated that the tentative annual expenditure of Rs.27.30 lakhs towards salary for the posts shall be met from the 6% Administrative Cost under MGNREGS. The Travelling Allowances to the above officials may also be met from the 6% administrative cost under MGNREGS. The Commissioner of Rural Development and Panchayat Raj has also proposed that

the above created posts shall be continued under the State funds, if sufficient project funds like MGNREGS, IAY, etc are not available at a future date.

5. The Government after careful examination of the proposal of Commissioner of Rural Development and Panchayat Raj and Government order the creation of the following posts for strengthening of the State Level NREGA Cell in the Directorate of Rural Development and Panchayat Raj, Chennai
