

## **ABSTRACT**

Mahatma Gandhi National Rural Employment Guarantee Scheme – Amendment notified by the Government of India to Schedule – I of the Mahatma Gandhi National Rural Employment Guarantee Act, 2005 reducing the working hours from 8 hours to 7 hours – Revision of Rural Schedule of Rates corresponding to 7 hours of works under Mahatma Gandhi National Rural Employment Guarantee Scheme – Approved - Orders issued.

## **ORDER:**

In the Government order first read above, the Government enhanced the wage rate under Mahatma Gandhi National Rural Employment Guarantee Scheme for the unskilled manual workers in Tamil Nadu from Rs.132/- to Rs.148/- and revised the Rural Schedule of Rates accordingly.

- 2. The Director of Rural Development and Panchayat Raj in the letter second read above, has stated that the Government of India have notified Mahatma Gandhi National Rural Employment Guarantee Act 2005 and in Schedule-I Para-8, it has been stated on the working hours under Mahatma Gandhi National Rural Employment Guarantee Scheme as follows:
  - "8. The schedule of rates of wages for unskilled labourers shall be so fixed that a person working for seven hours would normally earn a wage equal to the wage rate".
- 3. The Director of Rural Development and Panchayat Raj has also stated that the Government of India have further made the following Amendment to Para-8 as follows:

"(viii) in paragraph I, in sub-paragrah (1) after the words "for nine hours", the words "including an hour of rest" shall be inserted;"

Thus, the revised Para-8 of Schedule-I of Mahatma Gandhi National Rural Employment Guarantee Act reads as follows:

- "8. The schedule of rates of wages for various unskilled labourers shall be so fixed that an adult person working for nine hours including an hour of rest would normally earn a wage equal to the wage rate".
- 4. The Director of Rural Development and Panchayat Raj has further stated that the Government of India has now, revised the Schedule-I, vide Government of India notification dated 20.12.2013, wherein under Para 19, the working hours under Mahatma Gandhi National Rural Employment Guarantee Scheme as follows:
  - "19. (a) The schedule of rates of wages for various unskilled labourers shall be fixed up so that an adult persons worked for eight hours which include an hour of rest will earn a wage which is equal to the stipulated wage rate;
  - (b) The working hours of an adult worker shall be flexible but shall not spread over more than twelve hours on any day".
- 5. The Director of Rural Development and Panchayat Raj has also stated that the notified daily wage rate for Mahatma Gandhi National Rural Employment Guarantee Scheme works is Rs.148/- for the year 2013-14. Based on this, detailed Rural Schedule of Rates has been issued in Government Order first read above, the Schedule of Rate has been arrived based on a detailed Time and Motion Study conducted based on 8 hours of work by the Mahatma Gandhi National Rural Employment Guarantee Scheme workers in a day.
- 6. The Director of Rural Development and Panchayat Raj has also stated that Government of India have now reduced the actual working hours, by one hour, i.e., from 8 hours to 7 hours. As per the provisions of the Act, the schedule of rates for various unskilled works shall be fixed so that an adult person working for eight hours which include an hour of rest, will earn a wage which is equal to the stipulated wage rate; which essentially means, the Rural Schedule of Rates should be so fixed, so that the worker can get stipulated wage rate of Rs.148/- per day even for the reduced working hours. This can be achieved only by reducing the quantum of work to be done by the workers i.e. the quantum of work to be done in 7 hours should be 12.5% lesser than the quantum of work to be done in 8 hours and the Rural Schedule of Rates should be correspondingly modified.

- 7. The Director of Rural Development and Panchayat Raj has sent the details of reduction in the quantum of work in each category or item of activity and the corresponding revision in the Rural Schedule of Rates. The Director of Rural Development and Panchayat Raj has therefore requested the Government to approve the quantum of work to be done for 7 hours and the revised Rural Schedule of Rates corresponding to 7 hours of works under Mahatma Gandhi National Rural Employment Guarantee Scheme.
- 8. The Government, after careful examination of the proposal of the Director of Rural Development and Panchayat Raj, have decided to accept it and approve the quantum of work to be done for 7 hours and the revised Rural Schedule of Rates corresponding to 7 hours of works under Mahatma Gandhi National Rural Employment Guarantee Scheme consequent to the amendment notified by the Government of India to the Schedule-I of the Mahatma Gandhi National Rural Employment Guarantee Act 2005 as annexed to this Government Order.
