ORDER:

The Director of Rural Development and Panchayat Raj, in the letter fifth read above, has stated that in the Central Empowered Committee on Labour Budget meeting held on 11.3.2015, the Empowered Committee has scrutinized and approved the Labour Budget proposal of 37.29 Crore Person days for the State of Tamil Nadu for the year 2015-16. In Government of India letter No.J-11060/14/15-MGNREGA-VI SI.No.18, dated 06.04.2015, letter No.12034/1/2015-MGNREGA-VI.SI.No.37, dated:16.06.2015 and Letter No.J-12034/1/2015-MGNREGS-VI, SL. No.64, dated 25.08.2015 the Government of India has released grants-in-aid totaling Rs.3100.5721 Crore to Government of Tamil Nadu as first and second quarter of Central assistance for implementation of the MGNREGA for the financial vear 2015-16. Accordingly, orders have been issued in G.O.(Ms) No. 55, RD & PR (CGS -1) Department, dated 13.4.2015, G.O.(Ms) No. 91, Rural Development and Panchayat Raj (CGS -1) Department, dated 18.6.2015 and G.O.(Ms) No. 114, Rural Development and Panchayat Raj (CGS -1) Department, dated 31.08.2015 sanctioning and permitting the Director of Rural Development and Panchayat Raj to draw the above amount of Rs.3100.5721 Crore and transfer the amount to the State Employment Guarantee Fund Account of Tamil Nadu.

2. The Director of Rural Development and Panchayat Raj, has also stated that as no sufficient funds were available in the SEGF account to meet the wages requirement and the material component requirements of the State for the remaining months of the financial year 2015-16, proposals were sent to Government of India seeking additional funds to the tune of Rs.3758.89 crore.

3. The Director of Rural Development and Panchayat Raj, further stated that the Government of India have issued orders releasing funds to the tune of Rs.2369,80,26,000/- (Rupees Two Thousand Three Hundred and Sixty Nine Crore Eighty Lakh and Twenty Six Thousand Only) as under MGNREGS Scheme towards 3rd quarter and January and February 2016 of Central Assistance for the year 2015-16 on condition that the State Government must transfer these funds along with the State share to the State Employment Guarantee Fund for programme implementation within 3 days of receipt of funds failing which the State Government would be liable to pay a penal interest of 12% for the period of delay beyond the specified period.

4. The Director of Rural Development and Panchayat Raj, has also stated that a sum of Rs.5248.00 crore have been provided in the B.E. 2015-16 out of which a sum of Rs. 3181.9721 crore has been drawn so far which includes a sum of Rs. 81.40 crore drawn as State share. Now, a sum of Rs.5248.00 crore alone has been provided in the B.E. for 2015-16.

5. The Director of Rural Development and Panchayat Raj, has therefore requested the Government to sanction a sum of Rs.2369,80,26,000/- i.e., a sum of Rs. 303,77,47,000/- over and above the B.E for 2015-16 as detailed below under the following head of account:-

The Government, after careful examination of the proposal of the Director of Rural Development and Panchayat Raj, accord sanction for a sum of Rs.2369,80,26,000/- (Rupees Two thousand three hundred and sixty nine crore eighty lakh and twenty six thousand only) towards 3rd quarter and January and February 2016 of Central assistance under MGNREGS for the year 2015-16.
