## ORDER:

The Director of Rural Development and Panchayat Raj in the letter second read above, has stated that the Empowered Committee has scrutinized and approved the Labour Budget proposal of 37.29 Crore Persondays for the State of Tamil Nadu for the year 2015-16. The Government of India has released grants-in-aid totaling **Rs. 355.7881** Crore to Tamil Nadu as first tranche of Central Assistance for implementation of the Mahatma Gandhi National Rural Employment Guarantee Act for the financial year 2015-16 on condition that the State Government must transfer these funds along with the State share to the State Employment Guarantee Fund for programme implementation within 3 days of receipt of funds failing which the State Government would be liable to pay a penal interest of 12% for the period of delay beyond the specified period.

2. The Director of Rural Development and Panchayat Raj has therefore requested orders of the Government on the following:-

 to sanction a sum of Rs.355.7881 crore as part of first tranche of Central Assistance for the year 2015-16 as detailed below under the following head of account:
