## ORDER:

The Director of Rural Development and Panchayat Raj, in the letter third read above, has stated that in the Central Empowered Committee on Labour Budget meeting held on 11.3.2015, the Empowered Committee has scrutinized and approved the Labour Budget proposal of 37.29 Crore Persondays for the State of Tamil Nadu for the year 2015-16.

2. In Government of India's letter No.J-11060/14/2015-MGNREGA–VI SL.No.18, dated 6.4.2015, Government of India has released grants-in-aid totaling Rs. 355.7881 Crore to Tamil Nadu as part of first tranche of Central assistance for implementation of the Mahatma Gandhi National Rural Employment Guarantee Act for the financial year 2015-16. Accordingly, orders were issued sanctioning the above sum of Rs.355.7881 Crore as part of first tranche of Central assistance for the year 2015-16 in G.O (Ms) No.55, Rural Development and Panchayat Raj (CGS.1) Department, dated 13.4.2015.

3. The Director of Rural Development and Panchayat Raj has stated that he has sent proposal to Government of India seeking the release of balance of first tranche of Central assistance for the year 2015-16. Accordingly, the Government of India in letter No. J-12034/1/2015-MGNREGA–VI SI.No.37, dated 16.6.2015, have released a sum of Rs.1673.1168 Crore to Tamil Nadu as on account payment of part of 1<sup>st</sup> quarter of

Central Assistance for implementation of the Mahatma Gandhi National Rural Employment Guarantee Act for the financial year 2015-16 on condition that the State Government must transfer these funds along with the State share to the State Employment Guarantee Fund for programme implementation within 3 days of receipt of funds failing which the State Government would be liable to pay a interest of 12% for the period of delay beyond the specified period.

4. The Director of Rural Development and Panchayat Raj has therefore requested the orders of the Government to sanction a sum of Rs.1673.1168 Crore as on account payment of part of 1<sup>st</sup> quarter of Central Assistance for implementation of the Mahatma Gandhi National Rural Employment Guarantee Act for the financial year 2015-16 as detailed below under the following head of account:

The Government, after careful examination of the proposal of the Director of Rural Development and Panchayat Raj, accord sanction for a sum of Rs.1673.1168 Crore (Rupees One Thousand Six Hundred and Seventy Three Crore Eleven Lakh and Sixty Eight Thousand Only) towards part of first quarter of Central assistance under MGNREGS for the year 2015-16.
