### **ORDER:**

The Director of Rural Development and Panchayat Raj in the letter read above has stated that the Empowered Committee has scrutinized and agreed to the Labour Budget proposal of 31.55 Crore persondays for the State of Tamil Nadu for the year 2016-17 in Ministry of Rural Development, Government of India Letter No.J-12034/1/2016-MGNREGA-VI (347654), dated: 16.03.2016.

2. The Director of Rural Development and Panchayat Raj has also stated that in Ministry of Rural Development Government of India Letter No. J-12034/2/2016- MGNREGA-VI, SI.No.30, dated 22.04.2016, the Government of India has released a sum Rs.749,76,60,000/- to Tamil Nadu as 1<sup>st</sup> part of first tranche of Central Assistance for implementation of the Mahatma Gandhi National Rural Employment Guarantee Act for the financial year 2016-17 on the condition that the State Government must transfer these funds along with the State share to the State Employment Guarantee Fund for the programme implementation within 3 days of receipt of funds failing which the State Government would be liable to pay a penal interest of 12% for the period of delay beyond the specified period.

3. The Director of Rural Development and Panchayat Raj has therefore requested orders of Government on the following:

- a) to sanction a sum of Rs.749,76,60,000/- (Rupees Seven Hundred and Forty Nine Crore Seventy Six Lakh and Sixty Thousand Only) as 1<sup>st</sup> part of 1<sup>st</sup> Tranche of Central Assistance as detailed below under the following head of account:

The Government, after careful examination of the proposal of the Director of Rural Development and Panchayat Raj accord sanction for the sum of Rs.749,76,60,000/- (Rupees Seven Hundred and Forty Nine Crore Seventy Six Lakh and Sixty Thousand Only) towards first part of first Tranche of Central Assistance under Mahatma Gandhi National Rural Employment Guarantee Scheme for the year 2016-17.
