## ORDER:

The Director of Rural Development and Panchayat Raj in the letter read above, has stated that the Empowered Committee has scrutinized and agreed to the Labour Budget proposal of 31.55 Crore persondays for the State of Tamil Nadu for the year 2016-17 in Ministry of Rural Development, Government of India Letter No.J-12034/1/2016-MGNREGA-VI (347654), dated: 16.03.2016. The Government of India vide letter No. J-12034/2/2016-MGNREGA-VI, Sl.No.30, dated 22.04.2016 & Letter No. J-12034/2/2016-MGNREGA-VI, Sl.No.67, dated 19.05.2016 released a sum of Rs.1158.4508 Crore (ie., Rs.749.7660 Crore + Rs.408.6848 Crore ) to Tamil Nadu towards first and second part of 1<sup>st</sup> Tranche of Central Assistance for implementation of the Mahatma Gandhi National Rural Employment Guarantee Act and liquidating the pending liability of material component for the year 2015-16 under Mahatma Gandhi National Rural Employment Guarantee Scheme respectively. Accordingly, the Government had Sanctioned for release of a sum of Rs. 749.7660 Crore and Rs.408.6848 Crore vide G.O.(MS) No.52, Rural Development and Panchayat Raj (CGS1) Department, Dated:28.04.2016 and G.O.(MS) No.62, Rural Development and Panchayat Raj (CGS1) Department, Dated:26.05.2016 respectively.

2. The Director of Rural Development and Panchayat Raj has also stated that Government of India have released a sum of Rs.1200,00,00,000/- (Rupees One Thousand Two Hundred Crore Only) to Tamil Nadu towards 3<sup>rd</sup> part of 1<sup>st</sup> tranche of Central Assistance for implementation of the Mahatma Gandhi National Rural Employment Guarantee Act for the financial year 2016-17 on condition that the State Government must transfer these funds along with the State share to the State Employment Guarantee Fund for programme implementation within 3 days of receipt of funds failing which the State Government would be liable to pay a penal interest of 12% for the period of delay beyond the specified period.

3. The Director of Rural Development and Panchayat Raj has therefore requested order of the Government on the following:

- a) to sanction a sum of Rs.1200,00,00,000/- (Rupees One Thousand Two Hundred Crore Only) towards 3<sup>rd</sup> part of 1<sup>st</sup> tranche of Central Assistance as detailed below under the following head of account:
