Mahatma Gandhi National Rural Employment Guarantee Scheme - Construction of 50 Milk Collection Centres in rural areas at a total cost of Rs.6.26 crore under MGNREGS for the year 2018-19 - Permission accorded – Orders - Issued.

ORDER:

In the letter read above, The Director of Rural Development and Panchayat Raj has stated that *Para 7.7(c) of Annual Master Circular 2018-19* of MGNREGA permits the construction of Milk Collection Centres for collection, storage, value addition and marketing for the benefit of the Milk Producers / Farmers in rural areas. During the year 2016-17, 50 numbers of Milk Producers Cooperative Society Buildings were taken under MGNREGS at a unit cost of Rs.10 lakh. The Director of Rural Development and Panchayat Raj has therefore proposed to construct 50 numbers of Milk Collection Centres at a unit cost of Rs.12.51 Lakh.

2. The Director of Rural Development and Panchayat Raj has evolved the following norms for the execution of Milk Collection Centres in rural areas:

- (i) The site selected for the construction of Milk collection Centres should have been registered in the name of society.
- (ii) In selection and prioritization of the beneficiary society , the District level primary milk producer co operative society should be consulted.
- (iii) The construction of Milk Collection Centres should be as per the design and drawing.
- (iv) The guidelines already issued in G.O.(Ms) No.38 RD & PR(CG.S.1) Department, Dated 23.03.2017 should be adopted.

Non - negotiable items

1. Citizen Information Board shall be kept at the work site in 3 X 4 feet with all necessary information as per the framework given by the Government of India vide Ref No: k11023 /1 / 12017 – MGNREGA (IV), MORD, Dated 07.04.2017. Since this is a community type structure, the cost of Citizen Information Board will be fixed at Rs.4,500/-per unit. which should be included in the estimate itself.
2. Geo Tagging of the Assets shall be done for all 3 stages namely Before, During and After completion of the work.
3. MGNREGS work file (Checklist / Contents) has to be maintained for all works as per the instructions of Gol, vide Ref no: J11017/6/12016 – MGNREGA (VII), MORD, Dt 21.12.2016.
4. The Rural Schedule of Rate finalized in G.O. Ms.No.56, RD&PR (CGS.1) Department, Dated 17.04.2018 shall be adopted. In case of any revision made in Rural Schedule of Rates (RSoR) in future, the same shall be adopted.

3. Further, the Director of Rural Development and Panchayat Raj has stated that the unit cost for the construction of Milk Collection Centres is Rs.12.51 Lakh. The labour and material cost ratio is 8.47:91.53. 100% of the labour cost is borne by the Government of India while the material cost is shared in the ratio of 75:25 by the Government of India and the State Government .The unit cost has been arrived as per the standard type design. However the actual estimate cost may vary according to the site condition. Further the Director of Rural Development and Panchayat Raj has worked out the funding pattern for the construction of Milk Collection Centres under MGNREGS for the year 2018-19 as follows:-

The Director of Rural Development and Panchayat Raj has also stated that the district wise target for the construction of 50 Milk Collection Centers during 2018-19 under MGNREGS will be arrived after getting the list of Primary Milk Producer Cooperatives having own land in the name of the Society from the Milk Production and Dairy Development Department.

5. The Director of Rural Development and Panchayat Raj has therefore requested permission from the Government for the construction of 50 Milk Collection Centers at a total cost of Rs 6.26 crore under MGNREGS for the year 2018-19.

6. The Government, after careful examination of the proposal of the Director of Rural Development and Panchayat Raj, accord permission for the construction of 50 Milk Collection Centers at a total cost of Rs 6.26 crore under MGNREGS for the year 2018-19, subject to the condition that the Financial sanction will approved after getting the release of Central share.

7. This order is issued with the concurrence of Finance Department vide it's U.O. No. 37341/Finance (RD) /2018, dated 26.07.2018.
