ABSTRACT

MGNREGS - Announcement of the Hon'ble Chief Minister of Tamil Nadu under Rule 110 in the Floor of the Legislative Assembly on 12.06.2018 – Construction of 1000 Anganwadi Centre Buildings under MGNREGS in convergence with Integrated Child Development Services Scheme (ICDS) at a total cost of Rs.87.00 crore for the year 2018-19 – Permission accorded – Guidelines approved - Orders - Issued.

ORDER:

The Hon'ble Chief Minister of Tamil Nadu had made the following announcement under Rule 110 on the Floor of Legislative Assembly on 12.06.2018

“ஊரகப் பகுதிகளில் நடப்பாண்டில், 8 லட்சத்து 70 ஆயிரம் ரூபாய் மதிப்பீட்டில், 1,000 அங்கள் வாடி மையங்கள், 87 கோடி ரூபாய் செலவில் கட்டப்படும்”.

2. In the letter 2nd read above the Director of Rural Development and Panchayat Raj has stated that Anganwadi Centres are being constructed in rural areas, so as to provide nutrition, preschool education, and to inculcate the habit of personal hygiene among children, adolescents, pregnant and nursing mothers. In the Anganwadi centres, the children from two to five years are provided with supplementary nutrition, hot cooked meal, health care and pre-school education. Also adolescent girls, pregnant and lactating mothers are provided with supplementary nutrition besides health care, awareness education and capacity building initiatives. These Anganwadi centres are the durable assets and play a vital role in promoting health and preschool education at village level and function as creche for the children of MGNREGS workers in all the villages. Therefore, the Director of Rural Development and Panchayat Raj has proposed to construct 1000 Anganwadi Centres in convergence with the Social Welfare and Nutritious Meal Programme Department.

3. The Director of Rural Development and Panchayat Raj has also stated that the Revised Schedule-I of the National Rural Employment Guarantee Act, 2005 Paragraph 4 (1) IV Category-D: (v) permits the construction of buildings for Gram Panchayats, Women Self-help groups, federations, cyclone shelters, Anganwadi Centres, Village haats and crematoria at the Village or Block Level.

4. Further the Director of Rural Development and Panchayat Raj has stated that para 7.5.2 of the Annual Master Circular 2018-19 of MGNREGA as follows;

“Anganwadi Centres may be taken under MGNREGA using appropriate labour intensive and cost- effective technologies and local building materials. Expenditure up to Rs. 5.00 lakh under MGNREGA is allowed and the balance cost as per the state specific estimate may be mobilised from the Integrated Child Development Services (ICDS) schemes of the Ministry of Women and Child Development, Gol and other schemes”.

The Director of Rural Development and Panchayat Raj has proposed to construct 1000 Anganwadi Centre Buildings at an unit cost of Rs.8.70 lakh (Rs.5.00 lakh under MGNREGS, Rs.2.00 lakh under ICDS from Social Welfare Department and Rs.1.70 lakh from Panchayat Union General Fund or Panchayat General Fund) under MGNREGS in convergence with Integrated Child Development Services Scheme (ICDS) at a total cost of Rs.87.00 crore as per the Rural Schedule of Rates (RSoR) 2018-19.

5. The Director of Rural Development and Panchayat Raj has stated that the estimated cost for construction of One Anganwadi Centre is Rs.8,70,000/-. The labour and material cost ratio is 13:87. 100% of the labour cost is borne by the Gol and the material cost is shared in the ratio of 75:25 by the Gol and the State Government. The Director of Rural Development and Panchayat Raj has worked out the funding pattern for Construction of 1000 Anganwadi Centre buildings under MGNREGS for the year 2018-19 as follows:-

6. The Director of Rural Development and Panchayat Raj has therefore requested permission for construction of 1000 New Anganwadi Centres in convergence with Social Welfare Department at a total cost of Rs.87 Crore which includes Rs.50 crore under MGNREGS, Rs.20 crore under Social Welfare Department and Rs.17 crore under Panchayat Union General Fund or Panchayat General Fund during the year 2018-19 and approval of the guidelines therefor.

7. The Government, after careful examination of the proposal of the Director of Rural Development and Panchayat Raj, accord permission for the construction of 1000 New Anganwadi Centres in convergence with Social Welfare Department at a total cost of Rs.87 Crore which includes Rs.50 crore under MGNREGS, Rs.20 crore under Social Welfare Department and Rs.17 crore under Panchayat Union General Fund or Panchayat General Fund during the year 2018-19 and approved the guidelines as annexed in this order, subject to the condition that the Financial sanction shall be approved after getting the release of Central share.

8. This order is issued with the concurrence of Finance Department vide it's U.O. No. 37071/Finance (RD) / 2018, dated 01.08.2018.

Guidelines for Construction for Anganwadi Centres under MGNREGS

G.O.(Ms) No.125 , Rural Development and Panchayat Raj (CGS.1) Department,
Dated 12 .09.2018

Introduction:

Anganwadi Centres are being constructed in rural areas, so as to provide nutrition, preschool education, and health and to inculcate the habit of personal hygiene in children, adolescents, pregnant and nursing mothers. In the Anganwadi centres, the children from two years to five years are provided with supplementary nutrition, hot cooked meal, health care and pre-school education and also adolescent girls, pregnant and lactating mothers with supplementary nutrition besides health care, awareness education and capacity building initiatives. These Anganwadi centres are the durable assets and are very much useful in promoting health and education at village level and also take care of the children of MGNREGS workers in all the villages.

Selection of work:

The Project Director, DRDAs shall be directed to consult the Project Officer, ICDS / Social welfare Department in the district, for identifying the location for Anganwadi centres. The proposed work shall be approved by the Gram Sabha of concerned Village Panchayat.

Design Criteria:

The Anganwadi Centre should be child-friendly with all relevant infrastructure facilities like child-friendly classroom with black board(upto sill level), painted cartoon, separate kitchen, store for storing food items, child-friendly toilet and toilet for differently abled, ramp, compound wall, play materials and kitchen gardens.

Non-Negotiable Items:

1. Citizen Information Board shall be kept at the work site in 3 X 4 feet with all necessary information as per the framework given by the Government of India vide Ref No: k11023 /1 / 12017 – MGNREGA (IV), MORD, Dated 07.04.2017. Since this is a community type structure, the cost of Citizen Information Board will be fixed at Rs.4,500/- per unit. The cost of the Citizen Information Board shall be included in the estimate itself.
2. Geo Tagging of the Assets shall be done for all 3 stages namely Before, During and After completion of the work.


3. MGNREGS work file (Checklist / Contents) as per the instructions of Gol, vide Ref no: J11001017/6/12016 – MGNREGA (VII), MORD, Dt 21.12.2016 has to be maintained for all works.
4. The Rural Schedule of Rate finalised in G.O. Ms. No.56, RD&PR (CGS.1) Department, Dated 17.04.2018 shall be adopted. In case of any revision made in Rural Schedule of Rates(RSoR) in future, the same shall be adopted.

Technical Specifications:

1. Economical foundation footing is to be adopted based on the soil condition at site.
2. Flooring for classroom should be done using ceramic tiles.
3. Granolithic floor finish shall be adopted for kitchen and store.
4. Anti-skid tiles must be used for toilet area.
5. Weathering course should be provided.
6. Baby friendly toilet should be constructed based on the guidelines issued specifically under this category.
7. Toilet for differently-abled should be constructed with ramp provision.
8. Ramp should be provided at the entrance of the building and Kitchen garden should be set-up within the premises.
9. Provision for tactile and signages for differently-abled should be given compulsorily.
10. Compound wall should be constructed compulsorily.
11. Paintings of pet animals/popular cartoon characters, over the classroom wall, toilet and compound will create a friendly environment. The provision for the same should be included in the estimate.
12. Provision for procurement of play materials for children should be included in the estimate.
