ORDER:

In the letter read above, the Director of Rural Development and Panchayat Raj has stated that, Government of India, Ministry of Rural Development has approved Labour Budget of 22 crore persondays under Mahatma Gandhi National Rural Employment Guarantee Scheme to Tamil Nadu for the financial year 2019-20 and the Revised Schedule I of the National Rural Employment Guarantee Act, 2005 Paragraph 4(1) IV Category-D: permits the construction of buildings for Gram Panchayats, Women Self Help Group Federations, Cyclone Shelters, Anganwadi Centres, Village Haats and Crematoria, Construction of play fields, Creating infra-structure for promotion of fisheries such as Fish Drying Yards, Storage Facilities. and promotion of fisheries in seasonal water bodies on public land. Accordingly, the Director of Rural Development and Panchayat Raj has now proposed to construct 50 Food Grain Godowns at a unit cost of Rs.12.58 lakh with a total cost of Rs.6.29 crore under Mahatma Gandhi National Rural Employment Guarantee Scheme during the year 2019-20.

- 2. The Director of Rural Development and Panchayat Raj has further stated that The Government of India have notified the wage rate for the financial year 2019-20 as Rs.229/- per day in respect of Tamil Nadu. Accordingly, the Rural Schedule of Rates for the year 2019-20, approved in G.O.(Ms), No.52, Rural Development and Panchayat Raj (CGS.1) Department, dated:09.04.2019 and G.O.(Ms).No.53, Rural Development and Panchayat Raj (CGS.1) Department, dated:15.04.2019 are adopted for this work. The detailed guidelines issued vide G.O.(Ms).No.109, Rural Development and Panchayat Raj (CGS.1) Department, dated:07.08.2018 regarding the construction of Food Grain Godowns shall be adopted and referred for Planning, selection of work, Type Design, Non-Negotiable items and Technical Specification without any change.
 - 3. Further the Director of Rural Development and Panchayat Raj has stated that the unit cost of Food Grain Godowns will be Rs.12.58 lakh. The Labour cost is 100% borne by the Government of India and the material cost is shared at the ratio of 75:25 by the Government of India and the State Government. The Director of Rural Development and Panchayat Raj has worked out the funding pattern for construction of 50 Food Grain

The Director of Rural Development and Panchayat Raj has requested permission from the Government for the construction of 50 Food Grain Godowns at a total cost of Rs.6.29 crore under Mahatma Gandhi National Rural Employment Guarantee Scheme for the year 2019-20 and also to adopt the guidelines issued vide G.O.(Ms).No.109, Rural Development and Panchayat Raj (CGS.1) Department, dated 07.08.2018 regarding the construction of Food Grain Godowns for the year 2018-19.

The Government, after careful examination of the proposal of the Director of Rural Development and Panchayat Raj have decided to accept it and accord sanction for the construction of 50 Food Grain Godowns at a total cost of Rs.6.29 crore under Mahatma Gandhi National Rural Employment Guarantee Scheme for the year 2019-20 by adopting the guidelines issued in G.O.(Ms).No.109, Rural Development and Panchayat Raj (CGS.1) Department, dated:07.08.2018, subject to the condition that the financial sanction shall be approved after getting the release of Central Share.
