ORDER:

In pursuance of the sanction of Central Assistance under Mahatma Gandhi National Rural Employment Guarantee Scheme (MGNREGS) in the sanction order 3rd read above, orders were issued sanctioning a sum of Rs.1017,19,01,000/- (Rupees One Thousand Seventeen Crore Nineteen Lakh and One Thousand Only) towards Material component as 1st installment of 1st tranche of Central Assistance for the year 2022-23 along with the proportionate State Share of Rs.339,06,33,667/- (Rupees Three Hundred Thirty Nine Crore Six Lakh Thirty Three Thousand Six Hundred and Sixty Seven Only) and Rs.100,91,82,500/- (Rupees One Hundred Crore Ninety One lakh Eighty Two Thousand and Five Hundred Only) towards Administrative cost, totaling Rs.1457,17,17,167/- (Rupees One Thousand Four Hundred Fifty Seven Crore Seventeen Lakh Seventeen Thousand One Hundred and Sixty Seven Only) under Mahatma Gandhi National Rural Employment Guarantee Scheme for the year 2022-23.

2. In the sanction order 4th read above, now the Government of India accorded a sanction of Rs.414,13,95,500/- towards Material Component and Admin contingency (Rs.31322.13 lakh towards material component and Rs.10091.825 lakh towards Admin contingency) for implementation of the Mahatma Gandhi NREGA for the Financial year 2022-23.

3. Consequent on the above sanction by the Government of India, in the letter 5th read above, the Commissioner of Rural Development and Panchayat Raj has requested the Government to issue order sanctioning Rs.313,22,13,000/- (Rupees Three Hundred Thirteen Crore Twenty Two Lakh and Thirteen Thousand Only) towards Material component as 2nd installment of 1st tranche of Central Assistance for the year 2022-23 along with the proportionate State Share of Rs.104,40,71,000/- (Rupees One Hundred Four Crore Forty Lakh and Seventy One Thousand Only) and Rs.100,91,82,500/- (Rupees One Hundred Crore Ninety One lakh Eighty Two Thousand and Five Hundred Only) towards Administrative cost, totaling Rs.518,54,66,500/- (Rupees Five Hundred Eighteen Crore Fifty Four Lakh Sixty Six Thousand and Five Hundred Only) under relevant Heads of Account and to permit him to draw and transfer the amount through Treasury (PAO(South)) to the State Employment Guarantee Fund Account (Single Nodal Account) of Tamil Nadu.

4. The Government after careful examination of the proposal of the Commissioner of Rural Development and Panchayat Raj, accord sanction and release a sum of Rs.313,22,13,000/- (Rupees Three Hundred Thirteen Crore Twenty Two Lakh and Thirteen Thousand only) towards Material component as 2nd installment of 1st tranche of Central Assistance for the year 2022-23 along with the proportionate State share of Rs.104,40,71,000/- (Rupees One Hundred Four Crore Forty Lakh and Seventy One Thousand only) and Rs.100,91,82,500/- (Rupees One Hundred Crore Ninety One Lakh Eighty Two Thousand and Five Hundred only) towards Administrative cost, totaling Rs.518,54,66,500/- (Rupees Five Hundred Eighteen Crore Fifty Four Lakh Sixty Six Thousand and Five Hundred only) under Mahatma Gandhi National Rural Employment Guarantee Scheme for the year 2022-23.
