ORDER:

The Central Empowered Committee have approved Labour Budget for State of Tamil Nadu for the year 2022-23 at 22 crore person days and in the Notification 2nd read above wage rate was approved for Rs.281/- per person per day and as such, the State of Tamil Nadu is entitled for Rs.6,182 crore. Out of the approved

Labour Budget of 22 crore person days for the Financial Year 2022-23, as many as 660.64 lakh person days have been achieved till 25.06.2022.

2. In the orders 3rd & 4th read above, the Ministry of Rural Development, Government of India released the mother sanction order for Rs.2394,05,09,000/- (Rupees Two Thousand Three Hundred Ninety Four Crore Five lakh and Nine Thousand Only). Now, the Government of India in the order 5th read above, have sanctioned a sum of Rs.1118,10,83,500/- (Rupees One Thousand One Hundred and Eighteen Crore Ten lakh Eighty Three Thousand and Five Hundred Only) towards Material component and Admin contingency as 1st installment of 1st Tranche of Central Assistance for implementation of the Mahatma Gandhi National Rural Employment Guarantee Act for the financial year 2022-23.

3. In the letter 6th read above, the Commissioner of Rural Development and Panchayat Raj has stated that, taking into account the Government of India release of 75% share of material component of Rs.1017,19,01,000/- (Rupees One Thousand Seventeen Crore Nineteen Lakh and One Thousand Only), the State has to bear the balance 25% of the cost of the material component which amounts to Rs.339,06,33,667/- (Rupees Three Hundred Thirty Nine Crore Six Lakh Thirty Three Thousand Six Hundred and Sixty Seven Only).

4. The Commissioner of Rural Development and Panchayat Raj has therefore requested the Government to sanction a sum of Rs.1017,19,01,000/- (Rupees One Thousand Seventeen Crore Nineteen Lakh and One Thousand Only) towards Material component as 1st instalment of 1st tranche of Central Assistance for the year 2022-23 along with the proportionate State Share of Rs.339,06,33,667/- (Rupees Three Hundred Thirty Nine Crore Six Lakh Thirty Three Thousand Six Hundred and Sixty Seven Only) and Rs.100,91,82,500/- (Rupees One Hundred Crore Ninety One lakh Eighty Two Thousand and Five Hundred Only) towards Admin cost, totaling Rs.1457,17,17,167/- (Rupees One Thousand Four Hundred Fifty Seven Crore Seventeen Lakh Seventeen Thousand One Hundred and Sixty Seven Only) under Mahatma Gandhi National Rural Employment Guarantee Scheme for the year 2022-23 and to permit him to draw and disburse the amount to the State Employment Guarantee Fund Account (SNA) of Tamil Nadu.

5. The Government after careful examination of the proposal of the Commissioner of Rural Development and Panchayat Raj, accord sanction for a sum of Rs.1017,19,01,000/- (Rupees One Thousand Seventeen Crore Nineteen Lakh and One Thousand Only) towards Material component as 1st instalment of 1st tranche of Central Assistance for the year 2022-23 along with the proportionate State Share of Rs.339,06,33,667/- (Rupees Three Hundred Thirty Nine Crore Six Lakh Thirty Three Thousand Six Hundred and Sixty Seven Only) and Rs.100,91,82,500/- (Rupees One Hundred Crore Ninety One lakh Eighty Two Thousand and Five Hundred Only) towards Admin cost, totaling Rs.1457,17,17,167/- (Rupees One Thousand Four Hundred Fifty Seven Crore Seventeen Lakh Seventeen Thousand One Hundred and Sixty Seven Only) under Mahatma Gandhi National Rural Employment Guarantee Scheme for the year 2022-23.
