ORDER:

The Government of India in its letter 1st read above have sanctioned a sum of Rs.12,30,06,000/- (Rupees Twelve Crore Thirty lakh and Six Thousand only) as part of 1st installment of 1st tranche to the State Government of Tamil Nadu as Central Assistance towards conducting Social Audit in the State and staffing of independent Social Audit Unit for the financial year 2022-23.

2. In pursuance of the above release, the Commissioner of Rural Development and Panchayat Raj has requested the Government to issue orders for sanctioning a sum of Rs.12,30,06,000/- as part of 1st instalment of 1st Tranche to the State Government of Tamil Nadu as Central Assistance towards conducting Social Audit in the State and staffing of Independent Social Audit Unit for the financial year 2022-23 and to permit him to draw and transfer the amount to the Social Audit Society of Tamil Nadu (SASTA).

3. The Government after careful examination of the proposal of the Commissioner of Rural Development and Panchayat Raj, accord sanction for a sum of Rs.12,30,06,000/- (Rupees Twelve Crore Thirty Lakh and Six Thousand only) as
