ORDER:

In the Government order 4th read above, a sum of Rs.1457,17,17,167/- was released as 1st installment of 1st Tranche of Central Assistance for Material and Administrative Component for the financial year 2022-23 along with proportionate State share for Material component and in Government order 6th read above, a sum of Rs.518,54,66,500/- was released as 2nd installment of 1st Tranche of Central Assistance for Material and Administrative component for the financial year 2022-23 along with proportionate State share for Material component.

2. In the sanction order 7th read above, now the Government of India accorded a sanction of Rs.484,67,64,000/- (Rupees Four Hundred Eighty Four Crore Sixty Seven Lakh and Sixty Four Thousand Only) towards Material component and Rs.30,48,69,000/- towards Admin contingency as 1st installment of 2nd Tranche of Central Assistance for implementation of the Mahatma Gandhi NREGS for the financial year 2022-23.

3. Consequent on the above sanction by the Government of India, in the letter 8th read above, the Commissioner of Rural Development and Panchayat Raj has requested the Government to issue order sanctioning Rs.484,67,64,000/- towards Material component as 1st instalment of 2nd tranche of Central Assistance for the year 2022-23 along with the proportionate State Share of Rs.161,55,88,000/- and Rs.30,48,69,000/- towards Admin cost, totaling Rs.676,72,21,000/- under relevant Heads of Account and to permit him to draw and transfer the amount through Treasury PAO(South) to the State Employment Guarantee Fund Account.

4. The Government after careful examination of the proposal of the Commissioner of Rural Development and Panchayat Raj, accord sanction and release a sum of Rs.484,67,64,000/- (Rupees Four Hundred Eighty Four Crore Sixty Seven Lakh and Sixty Four Thousand Only) towards Material component as 1st instalment of 2nd tranche of Central Assistance for the year 2022-23 along with the proportionate State Share of Rs.161,55,88,000/- and Rs.30,48,69,000/- (Rupees Thirty Crore Forty Eight lakh and Sixty Nine Thousand Only) towards Admin cost, totaling Rs.676,72,21,000/- (Rupees Six Hundred Seventy Six Crore Seventy Two Lakh Twenty One Thousand Only) under Mahatma Gandhi National Rural Employment Guarantee Scheme for the year 2022-23.

Pending provision of such funds, the Commissioner of Rural Development and Panchayat Raj is authorized to draw and disburse the amount sanctioned in para 4 above. The Commissioner of Rural Development and Panchayat Raj is directed to include this item of expenditure while sending the budget proposal for FMA 2022-2023 and also send necessary draft explanatory note for inclusion of this expenditure in the Supplementary Estimate 2022-2023 to Government in Finance (RD / BG.I) Department at the appropriate time without fail.

7. The Commissioner of Rural Development and Panchayat Raj is authorized to draw and transfer the amount of Rs.676,72,21,000/- sanctioned in para 4 above to the Single Nodal Bank Account of the State Employment Guarantee Fund (Single Nodal Agency) as per the details given below:
