 This Office Letter No.Rc.No.50395/ 2021/ MGNREGS-I-1, Dt:05.02.2022.

I invite your kind attention to the reference cited.

Government has issued order for the construction of Working Sheds for SHGs to provide common infrastructure facilities in rural areas with the aim to provide proper capacity building development of skill for sustained livelihood activities vide reference cited

The district wise target for 500 Working Shed has been communicated to districts vide reference 2nd cited. As per the model estimate approved in GO, Working Shed should be constructed at a cost of Rs.9.60 Lakh with roofing height of 4.2 meter to place and use the factory/heavy machineries.

However, based on the requirement at field level modification shall be done for the type design and estimate amount communicated with GO. Accordinly, the following instructions are issued.

- The roofing height of 3.6 meter shall be adopted for the activities involving less SHG women like Garments and Jute Bags unit, Aari Works, Flouring Machine Units Weaving unit, Making Bamboo and Wire Basket, Terracotta Toys, Sanitary Napkins, Pot Making, Oil Extracting Units and Handicraft Unit etc.,
- Only for the activities involving heavy machineries with the height 3
 meter, the working sheds can be constructed with the roofing height of
 4.2 meter.

- Turbo ventilator facilities should be provided in the roof.
- The provision for Toilet facility was not provided in the existing model.
 Hence, a Mini CSC (Model-2) under SBM may be constructed for the
 completed and ongoing Sheds based on the need. For the new type
 designs also Toilets may be takenup under SBM if their available in the
 District.

However, depending on the number of SHG women/Activity involved in the work the new type design including toilet facility may be followed accordingly as follows.
