#### ORDER:

In the Government order first read above, orders have been issued revising the wage rate from Rs.273/- to Rs.281/- per person per day with effect from 01.04.2022 under Mahatma Gandhi National Rural Employment Guarantee Scheme (MGNREGS) and subsequently in Government Order second read above orders were issued approving the revised Rural Schedule of Rates for various types of activities under Mahatma Gandhi National Rural Employment Guarantee Scheme (MGNREGS).

- 2. In the Notification third read above, the Government of India have notified revision of wage rate to all States/Union Territories with effect from 1<sup>st</sup> April, 2023 under Mahatma Gandhi National Rural Employment Guarantee Scheme (MGNREGS) and in respect of Tamil Nadu, the wage rate has been revised as Rs.294/- per person per day.
- 3. In pursuance of the Notification issued by the Government of India, in the letter fourth read above, the Commissioner of Rural Development and Panchayat Raj has requested the Government to issue necessary orders revising the wage rate with effect from 1<sup>st</sup> April 2023, as Rs.294/- per person per day under Mahatma Gandhi National Rural Employment Guarantee Scheme (MGNREGS).

- 4. The Government after careful examination have decided to accept the proposal of the Commissioner of Rural Development and Panchayat Raj and to adopt the revised wage rate from Rs.281/- to Rs.294/- per person per day with effect from 01.04.2023 under Mahatma Gandhi National Rural Employment Guarantee Scheme (MGNREGS).
- 5. This order is issued with the concurrence of Finance Department vide its U.O.No.1077/FS/P/2023, dated 10.04.2023.
