ORDER:-

In the Meeting held on 16.03.2023, the Central Empowered Committee have approved Labour Budget for State of Tamil Nadu for the year 2023-24 as 20 crore persondays and it was revised as 37 crore persondays in the Empowered Committee meeting held on 13.12.2023.

2. In the Government Order 4th read above, orders were issued according sanction and release of Rs.886,41,67,000/- towards 75% share of Material component as 1st installment of 1st tranche of Central Assistance for the financial year 2023-24 along with 25% share of the proportionate State Share amount of Rs.295,47,22,333/- totaling to Rs.1181,88,89,333/- (Rupees One Thousand One Hundred and Eighty One Crore Eighty Eight Lakh Eighty Nine Thousand Three Hundred and Thirty Three Only) under Mahatma Gandhi National Rural Employment Guarantee Scheme for the year 2023-24. Moreover, in the Government Order 5th read above, orders were issued according sanction and release of Rs.735,00,00,000/- towards 75% share of Material component as 2nd installment of 1st tranche of Central Assistance for the financial year 2023-24 along with 25% share of the proportionate State Share amount of Rs.245,00,00,000/- (Rupees Two Hundred and Forty Five Crore Only) totaling to Rs.980,00,00,000/- (Rupees Nine Hundred and Eighty Crore Only) under Mahatma Gandhi National Rural Employment Guarantee Scheme for the year 2023-24. Now, in respect of Material component under MGNREGS, Government of India in its order 6th read above have sanctioned a sum of Rs.300,00,00,000/- (Rupees Three Hundred Crore Only) towards 75% of Material component as 1st installment of 2nd Tranche of Central Assistance for implementation of the MGNREGA for the financial year 2023-24.

3. In the letter 7th read above, the Director of Rural Development and Panchayat Raj, has stated that taking into account the Government of India release of 75% share of material component amounting to Rs.300,00,00,000/- (Rupees Three Hundred Crore Only), the State Government has to bear the balance 25% of the cost of the material component which amounts to Rs.100,00,00,000/- (Rupees One Hundred Crore Only). Therefore, the Director of Rural Development and Panchayat Raj has requested the Government to sanction a sum of Rs.300,00,00,000/- towards 75% share of Material component as 1st installment of 2nd tranche of Central Assistance for the financial year 2023-24 along with 25% share of the proportionate State Share amount of Rs.100,00,00,000/- (Rupees One Hundred Crore Only) totaling to Rs.400,00,00,000/- (Rupees Four Hundred Crore Only) under Mahatma Gandhi National Rural Employment Guarantee Scheme for the year 2023-24 and to permit him to draw and disburse the amount to the Material Component of the State Employment Guarantee Fund Account (SNA) of Tamil Nadu.

4. The Government after careful examination of the proposal of the Director of Rural Development and Panchayat Raj, accord sanction and release of Rs.300,00,00,000/- towards 75% share of Material component as 1st installment of 2nd tranche of Central Assistance for the financial year 2023-24 along with 25% share of the proportionate State Share amount of Rs.100,00,00,000/- (Rupees One Hundred Crore Only) totaling to Rs.400,00,00,000/- (Rupees Four Hundred Crore Only) under Mahatma Gandhi National Rural Employment Guarantee Scheme for the year 2023-24.
