

ABSTRACT

Indira Awaas Yojana – Loan obtained from HUDCO for Indira Awaas Yojana scheme on behalf of Government through Tamil Nadu Rural Housing and Infrastructure Development Corporation – A sum of Rs.4,12,04,489 (Rupees Four Crores twelve lakhs four thousand four hundred and eighty nine only) for settlement of Interest payment for the guarter ending 30.11.2014 – Sanction accorded - Orders - Issued.

ORDER:

In the Government order first read above, the Government have accorded sanction for obtaining loan under Indira Awaas Yojana from HUDCO for Rs.746.10 Crore (Rupees Seven Hundred and Forty Six Crores and Ten lakhs only) with necessary guarantee for loan liability and Budgetary Support every year for repayment of principal and floating rate of interest through Tamil Nadu Rural Housing and Infrastructure Development Corporation. Subsequently, in Government order second read above, among others, orders have been issued by the Government in Finance Department according unconditional and irrevocable guarantee for the repayment of loan for Rs.746.10 Crore to be availed from HUDCO by Tamil Nadu Rural Housing and Infrastructure Development Corporation along with interest thereon till, it is fully repaid. HUDCO has released the first instalment of the loan for Rs.373.17 Crore and the same was disbursed on 31.03.2014.

- 3. The Director of Rural Development and Panchayat Raj has also stated that proposal has been sent for budgetary provision for payment of Interest and repayment of Principal based on HUDCO demand. In the Government order third read above, the Government have ordered for payment of Interest for the quarter ending 31.05.2014 for Rs.5,72,53,479/- by way of drawal from contingency fund. In the Government order fourth read above, the Government in Finance Department has released the contingency fund and the same was paid to HUDCO on 31.05.2014.
- 4. The Director of Rural Development and Panchayat Raj has further stated that proposal has been sent for re-appropriation of funds for payment of interest and Principal repayment. In the Government order fifth read above, the Government have accorded sanction for Rs.25,72,75,862/- for principal repayment and for payment of Interest Rs.24,14,41,616/-. The provision available for Principal repayment requires no change since the amount due to be paid is Rs.25,72,75,862/-, which has been provided. Meanwhile, HUDCO has released instalment of Rs.372.93 Crore on 23.09.2014. But for interest payment the available budget provision is Rs.24,14,41,616/- as per G.O.(Ms) No.108, Rural Development and Panchayat Raj (CGS.1) Department, Dated 28.8.2014, out of which Rs.13,95,53,721/- has been utilized for interest payment for the quarter ending 31.05.2014 and 31.08.2014. The balance available is only Rs.10,18,87,895/-. But, the interest payment payable for the guarter ending 30.9.2014 is Rs.14,30,92,384/and for February 2015 is Rs.15,81,96,624/-. The total interest for the above two quarters in Rs.30,12,89,008/-. The total and the fund available is Rs.10,18,87,895/-. Therefore, additional fund required for interest payment is Rs.19,94,01,113/-. The total interest outgo for 2014-15 is Rs.44,08,42,729/-.
- 5. The Director of Rural Development and Panchayat Raj has therefore requested that additional funds of Rs.19.95 Crores may be sanctioned for settlement of Interest payment. The above amount, if sanctioned, will be included in the RE/FMA for 2014-15. He has also requested that the Director of Rural Development and Panchayat Raj / Managing Director, Tamil Nadu Rural Housing and Infrastructure Development Corporation may be empowered to draw the amount from Pay and Account Officer (South) Chennai for payment to HUDCO through Tamil Nadu Rural Housing and Infrastructure Development Corporation. He has further requested that the interest payment to HUDCO may be ordered to be debited to the following head of account:

"2216-Housing-03 Rural Housing -800 Other Expenditure State Plan – JE Payment of Interest for the loan obtained by TNRHIDC for implementation of IAY Scheme – 09 Grants in Aid – 04 Grants for Debt servicing" (DPC 2216-03-800-JE-0948)

6. The Government, after careful examination of the proposal of Director of Rural Development and Panchayat Raj, have decided to sanction for a sum of Rs.4,12,04,489 (Rupees Four Crores twelve lakhs four thousand four hundred and eighty nine only) for settlement of Interest payment for the quarter year ending on 30.11.2014 to HUDCO through Tamil Nadu Rural Housing and Infrastructure Development Corporation towards loan obtained from HUDCO for Indira Awaas Yojana scheme for the year 2014-15 over and above the amount sanctioned in the Government order fifth read above.

- 7. The Government authorize the Director of Rural Development and Panchayat Raj / Managing Director, Tamil Nadu Rural Housing and Infrastructure Development Corporation to draw the amount sanctioned in para 6 above from Pay and Account Officer (South) Chennai for payment to HUDCO through Tamil Nadu Rural Housing and Infrastructure Development Corporation.
- 8. The amount sanctioned in para 6 above shall be debited under the following heads of account:

"2216 Housing - 03 Rural Housing - 800 other Expenditure - Schemes in the Twelfth Five Year Plan - II. State Plan - JE Payment of interest for the loan obtained by TNRHIDC for implementation of IAY scheme - 09 Grants-in-Aid - 04 Grants for Debt servicing"
